1. IDENTIFICATION OF CRIMINAL CONDUCT

We are the ancestors of the first black indigenous peoples of Australia, and your attempts to kidnap, exile and possible assassinating a victim of torture violates the mandate of the United Nations. This conduct is currently under review by the UN Human Rights Council in Geneva. The State cannot arrest, detain or imprison a person who is not recognised in the Constitution. Rest assured that, I will never give up fighting for the recognition of "our ancestors" the first Black Indigenous Peoples of Australia in the Constitution until my last breath.

4. FINAL COMMAND
