3. **1. IDENTIFICATION OF CRIMINAL CONDUCT**

4. **This is a Criminal Suspect Female driver of REG.1 DJR 765 (KIA - SILVER) at address: 32A Mundford Street, North Beach WA 6020. A very jealousy female, selfish and always looking for issues all the time thinking that she is above the law. She is a hacker and have been hell-bent in zooming into my house, stealing sensitive information, Infringing upon my private life, hacking my Security Cameras, deleting evidence that implicates her and fellow Criminal Suspects gang and above all planning for my kidnapping and assassination with impunity, in direct contravention of article 3 and 9 of Universal Declaration of Human Rights (UDHR).**

They have been defaming me for too long zooming into my house causing anguish and discomfort in direct contravention of article 12 of the Universal Declaration of Human Rights (UDHR), and Article 17(1)(2) of the International Covenant on Civil and Political Rights (ICCPR).**

It is hypocrisy to hear this Female a Criminal Suspect yelling with anger and so protective of her name but is the same person who is hell-bent in zooming into my house every day for years now with impunity. When knowing very well that, I have never asked her to reveal her name. It is also very interesting to hear her angry voice that she hates me when knowing very well that, I don't talk to her. All my entire life I have sacrificed everything fighting like hell against bad governments so that the Community can have a better future, more financial support, Executive houses free of charge and be happy. The only token of appreciation I am getting from this Female a Criminal Suspect is insults and planning for my assassination.**

I have no doubt to Suspect and believe that, the governments of Australia are behind these Criminal activities because for many years of Complaining and seeking urgent action, but no action has ever been taken against repeated offenders. It has been proven that these Criminal Suspects are untouchable who commits offences and then walk away scot free with impunity in direct contravention of article 7 of the Universal Declaration of Human Rights (UDHR).**

**9. You are hereby identified as a primary suspect in a pattern of ongoing harassment, illegal zooming, and the theft of sensitive information. Your actions constitute Terrorising against my life and a shame to my beloved Continent Australia. I ask your Offices this time to find a room in your hearts no matter how connected you are with these Criminal Suspects, take urgent action against these repeated offenders to protect the image of Australia and Human Rights values.**

**10. Decision makers are bond to take into account peoples complaints very seriously. Nevertheless, your actions illustrates very clearly that you are bias with a bad culture of cover-up in favour of the offenders thus illegal and causing more danger and harm to my life.
