**FORMAL ADVISORY REGARDING
DEFAMATION, PERJURY, MISLEADING AND
PRIVACY VIOLATIONS.**

I. FORMAL DECLARATION OF LINEAGE AND STATUS:

I, Mr. Kidima Mubarak hereby issue this solemn affirmation to correct the record regarding persistent and malicious misinformation:
