SERIOUS AND URGENT DEMAND FOR ACTION AGAINST THE VIOLATION OF HIS EXCELLENCY MR KIDIMA MUBARAK'S PRIVACY.

- 1. Article 12 of Universal Declaration of Human Rights (UDHR) States that, No one "Shall" be Subjected to arbitrary interference with his Privacy, family home or Correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the Law against Such interference or attacks.**
- 2. Article 17 of the International Covenant on Civil and Political Rights (ICCPR) States that, No one "Shall" be Subjected to arbitrary or unlawful interference with his privacy, family, home or Correspondence, nor unlawful attacks on his honour and reputation. Everyone has the right to the protection of the law against Such interference or attacks. "End of Quotes".**
- 3. The Independent Global Movement Voice (IGMV) emphasizes that, every human being possesses the fundamental right to Personal liberty and Privacy within their own home. This includes the freedom to Speak, whisper, act and live Privately without any form of external interference, in Strict accordance with article 12 of the "UDHR" and article 17 of the "ICCPR".**
- 4. Therefore, we demand that, any leader-be it a King, President, Prime Minister, Minister or any Public Officer -who is involved in violating His Excellency Mr.Kidima Mubarak's Privacy or**

Who Supports Such violations, be recognized as acting in direct Contravention of the aforementioned International articles. Consequently, Such individual “must” be Compelled to resign and face prosecution in accordance with National and International Law.

The rights and Privacy of His Excellency Mr.Kidima Mubarak “must” be respected and protected at all Costs.

5. We further demand that, effective immediately, decisive action “must” be taken against any leader who fails to protect His Excellency Mr.Kidima Mubarak from any human rights abuses and Privacy violations.

Any leaders or public officials found Complicit in Cover-ups, or who Show negligence in acting against offenders, “must” be forced to resign and be prosecuted to ensure Such violations do not recur, in the best interest of the Public and the Global Community.
