- 1. Judicial Accountability and Human Rights:** It is evident that judicial presiding officers and public officials in Australia engage in behaviour suspected of being "cleverly racist" and bullying. They have deliberately refused to enact a Bill of Rights or recognize the First Black Indigenous People of Australia in the Constitution, serving Colonial governments that are considered unconstitutional under the UN Charter and the Universal Declaration of Human Rights.
- 2. Demand for Formal Apology:** We demand that the courts and the Attorney-General of Western Australia are considered Criminal Suspects for deliberately refusing to issue an unreserved, formal apology to His Excellency Mr. Kidima Mubarak. Certain officers of the court have harassed His Excellency and made ultra vires decisions with impunity, causing public shame, psychological torture, and harm to his future.
- 3. Misconduct Regarding Comrade Shariff:** Officials are deemed Criminal suspects for committing serious misconduct some years back by refusing to obey the mandate that Comrade Shariff be returned to the custody and care of his mother as a "minor" with immediate effect.
- 4. International Legal Obligations:** We condemn the deliberate refusal by Australia State to file a defense to the International Criminal Court (ICC), the European Union, and the United Nations, despite the fact that a case against the State of Australia and Western Australia State has been filed by His Excellency Mr. Kidima Mubarak some years back to seek justice for the community.
- 5. Protection of Private Life:** Criminal suspects with a bad culture of bias and cover-up continue to "zoom" into His Excellency's house, infringing upon his private life, stealing property, and terrorizing his family against his will. These individuals, predominantly of the Dutch ethnic tribe, are in direct Contravention of the UN Charter and the Universal Declaration of Human Rights.
- 6. Indigenous Rights:** We condemn the detainment and imprisonment of the Indigenous Peoples of Australia, particularly when they remain unrecognised in the Australian Constitution.
- 7. Jurisdiction of Rwenzururu Kingdom:** We emphasize that His Majesty Omusinga King Charles Wesley Mumbere, the King of Rwenzururu Kingdom is not the biological father of His Excellency Mr. Kidima Mubarak and has no jurisdiction to comment on or make decisions regarding His Excellency's personal family matters without proper consultation. We will, however, continue to support his kingdom where necessary.
- 8. Paternity Verification:** We reaffirm that Comrade Shariff is not a biological child of His Excellency Mr. Kidima Mubarak and the DNA results before the United Nations confirm this. We demand that any person found illegally alleging otherwise be arrested and prosecuted to protect the integrity and dignity of His Excellency Mr. Kidima Mubarak.

9. **Declaration of a Racist State:** Based on the above authority and the evidence filed under your jurisdictions, we hereby declare Australia a **"Clever racist State with a fake smile"**. This matter must be debated before the United Nations based on the evidence available in the public domain, in the best interest of the community.

10. **ICC Reform and Child Protection:** We demand for the abolition of Child Protection services. The ICC must be compelled to immediately open up **"nine court branches"** in Australia, staffed by Multicultural officials (**excluding the Dutch ethnic tribe**) to ensure proper, unbiased investigations.

11. **Deployment of UN Police:** We demand the Multicultural deployment of **"three battalions"** of the United Nations Police Force to Australia as a mandatory measure to protect witnesses. There is a clandestine apartheid and genocide occurring in Australia; this demand must not be taken lightly.

12. **Corruption and Misconduct:** We demand that the Corruption and Crime Commission (CCC) in Western Australia be abolished. Furthermore, the person who made a report dated **31st March, 2026**, under **Ref: 00435/2026**, regarding the serious complaints filed by His Excellency Mr. Kidima Mubarak must be investigated and prosecuted for serious misconduct.

13. **Cease Malicious Judgments:** We demand that, a bad culture of judging His Excellency Mr. Kidima Mubarak based on hearsay, assumption, malice, and envy, which tarnishes his good reputation, must cease immediately.

14. **Final Call for UN/ICC Implementation:** His Excellency Mr. Kidima Mubarak has endeavoured to teach Australians to respect the law and protect Human Rights, but his efforts have been ignored.

Even some reports from the UN High Commissioner for Human Rights and other organisations in regards to Human Rights Violations have been ignored by the Australia State.

The only solution is the deployment of **"three "Permanent" battalions"** of the UN Police Force and the establishment of **"nine "Permanent" International Criminal Court (ICC) branches"** across Western Australia (WA), New South Wales (NSW), Victoria (VIC), Queensland (QLD), South Australia (SA), Tasmania (TAS), Australia Capital Territory (ACT), Northern Territory (NT), and Jervis Bay Territory (NSW).

We remain humble servants to the Global Community and Champions of the Global Constitution.
