We demand that all Nations and States, Particularly in the Rural Areas, must be trained on how to be prepared in Case of Nuclear Catastrophic Consequences.

We demand that Such unlawful attacks must cease immediately and unconditionally.

We also demand that all military men and women who have been detained or imprisoned in the USA and parts of the Globe for opposing the Middle East wars, must be released immediately pursuant to Article 5,9 and 19 of the Universal Declaration of Human Rights (UDHR).
