Protective Intervention: This request is primarily based on immediate protective intervention and medical evacuation for further treatment in **Morocco**, pursuant to **Article 3 and Article 13** of the Universal Declaration of Human Rights (**UDHR**).

Travel Integrity: The requested rescue travel “must” not be used as a political football, for ransom, or for Clever kidnapping against my will, which stands in direct Contravention of **Article 9** of the Universal Declaration of Human Rights (UDHR).

AFFIRMATION OF PERSONAL STATUS:

Sovereign Affirmation: I, His Excellency Mr. Kidima Mubarak, solemnly affirm that I do not have family in Australia.

Independent Travel: I live alone and will be traveling alone to the designated destination, pursuant to **Article 12 and Article 13** of the Universal Declaration of Human Rights (UDHR).

CONDEMNATION AND REQUISITE STANDARDS:

Condemnation of Coercion: You cannot force me into illegal activities or compel me to travel with Criminal Suspects from address: 28 Mundford Street, North Beach WA, 6020, and address: 32A Mundford Street, North Beach WA 6020, against my will. Any attempt to enforce such activity will be considered a treasonous-General sense act.

Standards of Treatment: I request that this immediate protective intervention and medical evacuation be peaceful, stress-free, and entirely non-political. I deserve to be treated with dignity and respect.

Fundamental Rights: I demand peaceful and stress-free treatment for a better health in the best interest of the Global Community, pursuant to **Article 29(1)** of the Universal Declaration of Human Rights (UDHR).

Freedom of Conscience: I demand that my fundamental human rights and freedom of conscience be respected at all levels of governments and institutions, pursuant to **Article 18** of the Universal Declaration of Human Rights (UDHR).
