Formal Decree for Immediate Arrest: "We formally demand the immediate arrest, and prosecution of the Untouchable Dangerous Criminal Suspects located at 28 Mundford Street, North Beach WA 6020, and 32A Mundford Street, North Beach WA 6020, to ensure public safety and accountability."

Demand for Official Accountability: "We demand immediate arrest and Prosecution that all public officials involved in these matters be held fully accountable under the law for any negligence, delay, or failure to uphold their mandated duty."

Executive Demand for Action: "A formal request is made for the immediate investigation and appropriate legal processing of suspects residing at 28 Mundford Street, North Beach WA 6020, and 32A Mundford Street, North Beach WA 6020."

Reference to Prior Complaints: "Reference is made to multiple previous formal complaints and demands requesting that the documented activities be addressed and that a safety perimeter of 500 meters be established near the residence, which have not yet resulted in a resolution." Why take that long to act against these Dangerous Criminal Suspects.

Impact on Personal Well-Being: "The ongoing unaddressed activities continue to infringe upon private life, causing significant distress, discomfort, and a violation of personal peace with apparent impunity."

As I send this Decree, the Criminal Suspects are still in their houses doing the same Criminal activities of zooming into my house on a daily basis. Why do you even allow them near my house, when knowing very well that, I have just survived poisoning with the mercy of Almighty God, though not recovered. Whereby you have deliberately refused to investigate the poisoning situation.

Invocation of International Frameworks: "These unresolved actions are raised in direct reference to Article 12 of the Universal Declaration of Human Rights (UDHR), and Article 17 of the International Covenant on Civil and Political Rights (ICCPR)."

Last week I heard them saying that, they are not going anywhere until the job of assassinating me or exiling me is done. That a target should not miss this time according to the order from above. Why haven't you arrested them, when having enough evidence for Prosecution. How many times do you expect us to Complain and justify the removal of these dangerous untouchable Criminal Suspects 500 metres away from my house for the justice of my cause and peace?.

Why do you even allow my life/future to be ruin and reputation damaged on your watch?. How many complaints do you need to justify the arrest and prosecution of these untouchable dangerous Criminal Suspects?, Why do you even allow them to continue zooming into my bedroom with impunity?.

Inquiry on Procedural Delay: "Why have the relevant authorities permitted these documented activities to continue despite multiple formal complaints?" .

Inquiry on Protective Measures: "Why specific investigative steps haven't been taken to review the allegations of official negligence and the failure to uphold the mandated duty of care?".

Inquiry on Institutional Accountability: "Why protocols haven't been initiated to ensure that public officials thoroughly investigate serious claims regarding personal safety and prevent any potential oversight or cover-up?".

Bear in mind that, illegality cannot be considered legal". Immediate action must be taken against all Criminal Suspects.
