EXECUTIVE DECREE REAFFIRMING THE APPOINTMENT OF HER ROYAL HIGHNESS PRINCESS LALLA KHADIJA AS THE VICE - PRESIDENT OF THE (IGMV), SPECIAL ALLY, AND SENIOR NEXT OF KIN.

NOW, THEREFORE, IT IS DECREED AS FOLLOWS:

IMMEDIATE NOTIFICATION:

In accordance with Articles 1 and 2 of the Universal Declaration of Human Rights (UDHR), the appropriate authorities and Global Community are Strictly obligated to notify the "President immediately" upon the arrival of the Vice-President, Special ally and Senior next of Kin or in the event of any disturbance, Emergency, or trouble.

The Independent Global Movement Voice (IGMV) remains absolutely Committed to, and prepared for, the unwavering protection and Support of the Vice-President at all costs.
