Immediate Response Required: We demand an immediate response to our previous Communications regarding our Global Projects, Specifically the provision of **“Executive Free Housing”**.

No Projects without Housing: Let it be known that there Can never be any New projects in your Governments until the matter of **“Executive Free Housing”** is dealt with immediately.

The May Deadline: Come rain, come Shine, our Global Community **“must”** Start having Free Executive Houses within **this month of May 2026**.

NOTICE OF EXPIRED PATIENCE.

Multiple Extensions Granted: We have given you enough time and multiple extensions, yet you have never responded.

Seven-Day Ultimatum: We demand an urgent response within no more **than seven (7) days**, Starting immediately.

Consequences of Non-Compliance: Failure to Comply will leave you with only yourselves to blame. We will be left with no Choice but to rise up and demand for our fundamental right to have Executive (**Human-Free**) Housing.

International Intervention: We maintain our demand for the deployment of **Three Battalions of the UN Police Force** and the establishment of
