Incident Details:

Timeline: I have been experiencing Symptoms of illness Since Consuming mineral water yesterday, May 12, 2026.

Current Status: I am currently not feeling well and am concerned about the progression of these Symptoms.

Suspected Source: I believe the poisoning may be linked to a Collaboration between individuals, Criminal Suspects at address: 28 Mundford Street, North Beach WA 6020, and a Specific individual involved in packing my food at the Woolworths Shopping Centre.

I have previously overheard discussions regarding this intent and had been actively avoiding certain products until yesterday.

Request for Action:

While I have secured an appointment for Friday, 15 May 2026, at 9:00 AM, with my GP, my current physical Condition and the nature of this report require more immediate attention.

Immediate Evaluation: Please advise if I can be Seen Sooner or if you can authorise an immediate toxicology Screen at my house due to Political persecution and lack of Security protection, "I don't trust any Hospital in Australia".

Medical Record: Please ensure this report is formally documented in my medical file for legal and investigative purposes.
