**EXECUTIVE FORMAL DECREE FOR IMMEDIATE REMOVAL, ARREST AND PROSECUTION OF DANGEROUS UNTOUCHABLE CRIMINAL SUSPECTS LOCATED AT ADDRESS: 28 MUNDFORD STREET, NORTH BEACH WA 6020, AND 32A MUNDFORD STREET, NORTH BEACH WA 6020.**

Reference is made in regards to previous **“Executive Formal Decree for immediate arrest and Prosecution-**

**REF: KM/IGMV/51/2/05/2026,** dated **Wednesday 27th, 2026.** That you cannot continue allowing untouchable Criminal Suspects to ruin my life/Future on your watch.

**Whereas,** we demanded for the immediate arrest, and prosecution of the Untouchable Dangerous Criminal Suspects located at **28 Mundford Street, North Beach WA 6020,** and **32A Mundford Street, North Beach WA 6020,** to ensure public safety and accountability but all in vain.

**Whereas,** we also demanded for Official Accountability, immediate arrest and Prosecution that all public officials involved in these matters be held fully accountable under the law for any negligence, delay, or failure to uphold their mandated duty but all in vain.

**We also reminded you that,** Reference to Prior Complaints: "Reference is made to multiple previous formal complaints and demands that the documented activities be addressed and that a safety perimeter of **500 metres** be established near the residence, which have not yet resulted in a resolution." **Why take that long to act against these Dangerous Criminal Suspects?.**

Whereby you have deliberately refused to investigate the poisoning situation?.**

**Why do you Continue allowing them next to my house?, when knowing very well that their illegal activities and unresolved actions Contravenes Article 12 of the Universal Declaration of Human Rights (UDHR), and Article 17 of the International Covenant on Civil and Political Rights (ICCPR)."**

**When knowing very well that, the ongoing unaddressed activities continue to infringe upon private life, causing Significant distress, discomfort, and a violation of personal peace with apparent impunity. "When knowing very well that, these Untouchable Dangerous Criminal Suspects, are not supposed to be near my house - away 500 metres.**
