It is hereby formally demanded that the specified parties, (Dangerous Criminal Suspect and a leader of Illuminati in Perth Western Australia by the names of David, a driver of "REG.1 HYH.871", with snakes on the right side of the vehicle) observed in Western Australia, **(REG. 1724.871)**

at Address: **32A Mundford Street, North Beach WA 6020**, as per the photos attached, and (Criminal Suspect Ben Kaiser) "**Suspected Son of David**", along with all relevant individuals listed below, (Comrade Shariff, Criminal Suspect Bruce a driver of REG.BSN.17BR-Volkswagen TIGUAN Black) observed in Western Australia as per the Photo attached, a **Young female Criminal Suspect Sister of Ben**. (Criminal Suspect Kevin a driver of REG.1 HYH.203 TOYOTA YARIS-RED) observed in Western Australia, as per the photo attached all of them at **Address:28 Mundford Street, North Beach WA 6020**, "**must**" be compelled by appropriate authorities to undergo immediate, certified "**DNA**" testing to establish definitive legal verification.

We humbly request that the public should intervene and **pay for the DNA testing of David, Ben Kaiser and all individuals mentioned above in the public interest**. We also confirm our previous Formal Decree that, "**Comrade Shariff is not a child and will never be a child of His Excellency Mr.kidima Mubarak**". We also suspect that, Ben Kaiser is not a child of Comrade Shariff. We demand that a bad Culture of Cover-up in favour of some Dutch Offenders "**must**" **cease immediately** and those responsible "**must**" be held to account.

CONDEMNATION OF INVESTED INTERESTS AND EXPLOITATION: The Office of the Presidency strongly condemns the actions of individuals using children or familial matters as strategic or political tools, or utilizing external parties under pretense for personal or political leverage. Such practices represent a profound domestic failure, characterized by wilful blindness and bad faith.

PROTECTION OF THE PRESIDENCY AND CIVIL STANDARDS: We demand that any coordinated campaigns designed to undermine the status, future, or security of His Excellency Mr.Kidima Mubarak with impunity be systematically rejected. Such unvetted behaviour "**must**" be condemned at every administrative tier of government and across all formal institutions.

APPLICATION OF THE DOCTRINE OF IMPUTED KNOWLEDGE: Under the strict application of the Law of Agency and the Doctrine of Imputed Knowledge, all governing bodies and representatives are deemed formally notified. Principal entities remain fully accountable for the actions, omissions, and liabilities of their agents.

IMMEDIATE DISPOSITION OF PENDING COMPLAINTS: A strict directive is issued ensuring that all previously filed serious complaints regarding (**EXECUTIVE NOTICE:FINAL LEGAL WARNING, dated Saturday 7 February,2026**),against "**Criminal Suspect David**", and (**KIDIMA MUBARAK FORMAL EMERGENCY NOTICE REQUEST FOR INTERIM MEASURE URGENT APPEAL IMMEDIATE THREAT TO MY LIFE, dated Tuesday 20 January,2026**), under current jurisdictions—copies of which have been securely uploaded to the official website of His Excellency Mr.kidima Mubarak on even dates—be reviewed, investigated, and settled immediately to serve the definitive cause of justice.
