EXECUTIVE DIRECTIVES AND ORDERS.

We kindly request that, **"His Majesty King Mohammed VI and the Royal Family"** grant their blessings for your immediate travel to **"Perth, Western Australia"**, in the absolute best interest of the Global Community.

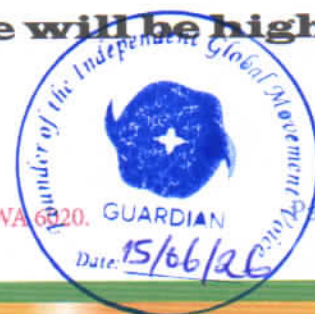
