DECLARATIONS AND MANDATES.

CONDEMNATION OF COERCED MARRIAGE:

The Office of the Presidency, (IGMV) declares that the practice of forcing individuals into marriage against their will and intuition is a profound violation of fundamental human rights.

We demand an immediate cessation of these practices, and assert that those complicit in such actions must be held fully accountable under relevant legal frameworks to safeguard the Community and protect human dignity.

ADVOCACY FOR VICTIMS: We strongly encourage victims of forced marriage to formally document and file their grievances with the United Nations High Commissioner for Human Rights (OHCHR) and the Independent Global Movement Voice (IGMV) for official record and administrative review.

**AFFIRMATION OF THE UNIVERSAL
DECLARATION OF HUMAN RIGHTS
(UDHR):**

Pursuant to **Articles 13 and 16** of the Universal Declaration of Human Rights (UDHR), every human being possesses the fundamental right to freedom of movement and the right to marry and found a family by their own free will.

Pursuant to **Articles 4 and 5**, of the **Universal Declaration of Human Rights (UDHR)**, forcing an individual into marriage through systemic pressure or coercion constitutes severe psychological distress, subjugation, and degradation. Those responsible for such abuse **“must”** face immediate legal accountability regardless of their social or institutional status.

Under **Articles 1, 2, 16(3), and 29**, of the **Universal Declaration of Human Rights (UDHR)**, the Global Community is reminded of its collective duty to intervene and dissolve harmful cultural practices that undermine individual liberty.

DEMAND FOR SPECIAL INTERNATIONAL INTERVENTION:

We issue a formal call to the United Nations and partner international organizations to intervene immediately. A thorough investigation must be launched into the circumstances surrounding the forced marriages. Immediate protective measures **“must”** be deployed to secure their freedom from duress, harassment, and intimidation, ensuring their right to choose their path safely in accordance with the **Universal Declaration of Human Rights (UDHR)** and the **UN Charter**.

PROTECTION OF THE SICK AND VULNERABLE:

In alignment with **Article 19** of the **Universal Declaration of Human Rights (UDHR)**, we firmly oppose/Condemn any actions driven by **Malice, Jealousy, Revange, Assumption** or **Hearsay** that compel the sick people, ill or vulnerable individuals to work against their will,

Medical or personal capacity. The dignity, health concerns, and personal agency of a sick person "must" be fully respected and protected under international standards.
