EXECUTIVE FORMAL DECREE FOR IMMEDIATE ARREST.

PREAMBLE AND RECOGNITION OF PREVIOUS CITATIONS:

This Decree formally references and incorporates the following prior filings and institutional updates:

International Criminal Court (ICC) Serious Complaints: Pursuant to case reference OTP-CR-397/18/001.

Updated Legal Notice to the Office of the Prosecutor (ICC): Under reference KM/23/2025 (dated Sunday, 18th January 2026) and the subsequent formal submission titled "Kidima Mubarak Notice to the International Criminal Court Registry and the Victims Participation and Reparations Section (VPRS) Constitutes, Pursuant to Article 15 of the Rome Statute" (dated Tuesday, 20th January 2026).

Prior Executive Mandates: In reference to Decree REF: KM/IGMY/60/16/06/2026 (dated Tuesday, 16th June 2026), regarding the formal condemnation of coerced practices.

LEGAL NOTICE: Pursuant to Article 51 of the Rome Statute, the Office of the Presidency explicitly reserves the absolute right to amend all previous case files under reference OTP-CR-397/18/001.

I, His Excellency Mr. Kidima Mubarak—in my capacity as Champion of Common Sense, Chairman of **Alkebulan**, Author of the Independent Voice Book, Global Constitution, Founder of the Matooke Project in Australia from Alkebulan, and Founder, President, and Chairman of the Independent Global Movement Voice (**IGMV**)—hereby submit this urgent formal complaint regarding the immediate well-being, safety, and security of our **Vice-President, Special Ally, and Senior Next of Kin, Her Excellency, Her Royal Highness Princess Lalla Khadija.**

Formal notice is given, I suspect that her safety is treated as compromised. Competent International authorities **“must”** intervene immediately to investigate her circumstances. Any failure to act against alleged offenders will be formally noted as a breach of the Court’s institutional duty of care to protect victims of international crime.

I suspect that **Her Excellency, Her Royal Highness Princess Lalla Khadija Vice - President of the Independent Global Movement Voice (IGMV)** was **kidnapped, raped, Psychologically tortured and her money was stolen** from her, when on Official duties in Perth Western Australia. It is also **suspected** that she was violently **raped** by an army officer in connivance with a **Dangerous Criminal Suspect “David Officer of the Court”**. I also suspect that, **she may be pregnant** as a result of such barbaric act against her will. **I demand that, if it’s true, then, immediate action “must”** be taken against the offenders regardless of their status, pursuant to article 33 of the Rome Statute. responsible must be held to account pursuant to article 25 of the Rome Statute.

Demands under the Rome Statute and International Law.

Accountability for Core Violations: In accordance with **Articles 25, 33, and 7** of the Rome Statute, immediate legal action must be taken against all individual suspects involved in unlawful actions, duress, or psychological deprivation targeting **Her Excellency, Her Royal Highness Princess Lalla Khadija**, regardless of their institutional or official status.

Waiver of Immunities: Pursuant to **Article 48** of the Rome Statute, we demand that the privileges and immunities of the primary suspect, **designated as David**, and his associated group, be formally waived, and that removal from office be executed in strict accordance with **Article 46**.

Cessation of Coercion and Protection of Free Will:

Pursuant to **Articles 13, 16, and 18** of the Universal Declaration of Human Rights (**UDHR**), every individual possesses the fundamental right to freedom of movement, freedom of thought, conscience, and the right to marry and found a family entirely by their own free will. Any parent, guardian, or official who obstructs her choice **"must"** face formal prosecution under international Law/ standards.

Humanitarian and Medical Autonomy: It is affirmed that any individual under severe duress retains absolute personal autonomy over their destiny, future, and reproductive healthcare decisions. No court or entity possesses the legal right to compel or enforce choices against an individual's explicit will.

Mitigation of Psychological Torture: We express grave concern that continued undue pressure and systemic isolation of **Her Excellency, Her Royal Highness Princess Lalla Khadija**, may cause catastrophic psychological distress or **suicide**. Stand warned that, all parties involved will be held strictly accountable. Coercive practices and dictations against her personal decisions **"must"** cease immediately, ensuring her complete freedom from psychological torture.

Directives to International Judicial Bodies:

Article 68 of the (Rome Statute): The International Criminal Court is requested to deploy immediate protection measures for the President and the Vice-President of the **(IGMY)**.

Article 75 of the (Rome Statute): The Court is urged to compel appropriate state parties and international bodies to facilitate immediate

reparations and compensation to the President and Vice-President of International Global Movement Voice **(IGMY)**.

Articles 86, 87, and 89 of the (Rome Statute): A formal request for international state cooperation is hereby issued. Relevant state authorities and the United Nations **"must"** cooperate fully to execute immediate judicial action against dangerous Criminal suspects.

CLOSING DECLARATIONS:

I call upon the Global Community to rise up and support this movement to rescue the Vice-President of the **(IGMY)** from danger and systemic harm, in accordance with **Articles 1, 2, 16(3), and 29** of the **(UDHR)**.
