Additionally, this investigation must extend to his family, Criminal Suspects **Ben Kaiser, Bruce** and others residing at address: **28 Mundford Street, North Beach WA 6020**, next to my house.

Please note that as I send this formal decree, the aforementioned dangerous criminal suspects remain in those houses, continuing their illegal activities of zooming into my house, bedroom against my will with impunity on your watch. **"Shame"**.

I demand an immediate formal response from the United Nations, the International Criminal Court (ICC), and other relevant institutions explaining why you have allowed those dangerous criminal suspects to continue terrorising my personal life with impunity on your watch, in direct contravention of **Article 12** of the Universal Declaration of Human Rights (UDHR) and **Article 17** of the International Covenant on Civil and Political Rights (ICCPR).

**Furthermore**, I demand an immediate formal explanation as to why you have never sent "UN Inspectors" to investigate the dangers of the suspected **"Nerve Agent"** poisoning at my house address: **30A Mundford Street, North Beach WA 6020**, in Western Australia.

**I reaffirm my previous formal demands that**, all Dangerous Criminal Suspects "must" be arrested and be prosecuted in accordance with National and International Law regardless of their status, Dutch ethnicity and Superiority.
