2. **URGENT REMINDER:** Reference is made as a serious and urgent reminder in regards to the Diplomatic Formal Appointment as Executive Authority for the Independent Global Movement Voice (IGMV) Mandates, REF: KM/IGMV/16/28/02/2026, dated 28th February 2026.

3. **IMPLEMENTATION OF RECOMMENDATIONS:** Whereas, on Paragraph (3), we requested the implementation of all IGMV recommendations regarding the Hadzabe and Black Indigenous Peoples across the globe, ensuring these actions are executed with the highest "Executive Standards."

4. **STATE COMPLIANCE:** Compelling all Member States to comply with the legal frameworks established in the Global Constitution, particularly concerning the 100% return of mineral resources, petroleum, and oil and gas royalties to the sovereign citizens of each State.

5. **INFRASTRUCTURE OVERSIGHT:** Ensuring the rapid and efficient rollout of the Executive Free Housing model in jungles, mountains, and other places across the globe, maintained to the strict hygiene standards required by the (IGMV).

6. **JUDICIAL ENFORCEMENT:** Facilitating the expansion of the International Criminal Court (ICC) to the district level across the globe to enforce anti-bullying laws and protect sovereign citizens from administrative overreach. We have been waiting but all in vain.

7. **RESPECT OF INTERNATIONAL LAW:** Whereas, we remind you about the previous Decree regarding the Respect of International Law, Human Rights, and Global Leadership Mandate, REF: KM/IGMV/17/2/03/2026, dated Monday, 2nd March 2026. Particularly on Page 2, Paragraph (3), demanding that a formal mechanism be established immediately to provide me with daily briefings on global security and incidents, knowing very well that the (IGMV) is a stakeholder in global peace and human rights protection and can no longer be bypassed.

8. **DIPLOMATIC SECURITY REQUEST:** Also concerning an extreme and very urgent request for diplomatic security and protection under the UN Framework, REF: KM/IGMV/18/7/03/2026, dated 7th March 2026. We have been waiting but all in vain.

9. **EMERGENCY HOUSING AND MOBILIZATION:** Furthermore, regarding the classification and immediate global requirement for emergency housing and resource mobilization, REF: KM/IGMV/20/10/03/2026, dated Tuesday, 10th March 2026. We have been waiting but all in vain.

EXECUTIVE FREE HOUSING MANDATE: And the Executive Free Housing mandate, REF: KM/IGMV/21/10/03/2026, dated Tuesday, 10th March 2026. We have been waiting but all in vain.

10. **PETITION TO IRAN:** Whereas, we sent an urgent petition for diplomatic security to the Islamic Republic of Iran, REF: KM/IGMV/23/12/03/2026, dated Thursday, 12th March 2026.

11. **STATUS OF INVESTIGATION:** Whereas, we sent an URGENT: STATUS OF INVESTIGATION AND DEMAND FOR IMMEDIATE PROTECTION OF HUMAN RIGHTS. We have been waiting but all in vain.

13. **SHAREHOLDER RECOGNITION (RUSSIA-AFRICA SUMMIT):** Whereas, we made a formal demand for the recognition and shareholder percentage regarding the 2019 Russia-Africa Summit, now called "Alkebulan," REF: **KM/IGMV/30/5/04/2026, dated Sunday, 5th April 2026**. Particularly on **Paragraph (II), Protection of Ideas**, whereby we made it very clear that the Independent Global Movement Voice (IGMV) stands against the theft or appropriation of people's ideas.

14. **LEGISLATION FOR INNOVATORS:** We also made it clear that robust legislation must exist to support and financially empower innovators.

15. **SPECIAL COMMITTEE ESTABLISHMENT:** Furthermore, it is requested that your honourable offices set up a special committee as a matter of urgency to compel the African continent (now "Alkebulan") and the Russian Federation to pay His Excellency Mr. Kidima Mubarak a reasonable percentage as a shareholder from each and every agreement signed in 2019, continuously and forever.

16. **RECOGNITION OF VISION:** We recognize that His Excellency Mr. Kidima Mubarak deserves to enjoy the fruits of his God-given common sense and vision in the pursuit of dignity and global happiness. Unfortunately, we have been waiting, but all in vain.

17. **ROYAL INTERVENTION DEMAND:** We demand that the Vice-President of (IGMV) and Senior next of Kin, **Her Royal Highness Princess Lalla Khadija**, must intervene and make a follow-up to secure immediate payments. Please rest assured that the (IGMV) alliance with **Her Royal Highness Princess Lalla Khadija** is inseparable.

18. **GLOBAL CAR MANUFACTURE AND RECYCLING MANDATE:** Whereas, we provided a fantastic idea for a "Project to Deal with Global Car Manufacture and Recycling Mandate," REF: **KM/IGMV/31/7/04/2026, dated Tuesday, 7th April 2026**, which was categorized as "The Recycled Mechanism, Old for New."

19.(a) **Swap-System:** We also proposed an (IGMV) revolutionary swap-system for the global transport industry initiated by His Excellency Mr. Kidima Mubarak. We target the operators of old minibuses, Kamunye's, and Matatu's—the backbone of the community movement.

(b) **The Mandate:** The mandate dictates that you hand in your old, polluting vehicle and receive a brand-new minibus immediately.

(c) **The Financial Shield:** We made it clear that there will be no upfront payment. A reasonable, interest-free weekly payment plan will be established via sovereign banks.

(d) **The Result:** More importantly, our mission is to clean the cities, restore passenger confidence and dignity, and move operators from survival mode to executive wealth.

(e) **Supervision:** We maintain our position that the entire project remains under the strict oversight of the Independent Global Movement Voice (IGMV).

20. **MASTER DECREE REMINDER:** Whereas, we sent you a Master Decree of the narrative of the Justice Struggle, the Vision for **Alkebulan**, and the Demand for Justice and Restitution, REF: **KM/IGMV/36/21/04/2026**, dated Tuesday, 21st April 2026.

21. **DEMAND FOR INTERVENTION:** Particularly on paragraph (III), whereby we made a formal demand for restitution and recognition at pages 4 and 5. We made a demand to the Government of the Commonwealth of Australia and relevant authorities that we hereby issue this formal demand for intervention based on the following imperatives.

22. **IMMEDIATE RECOGNITION (MATOOKE PROJECT):** Immediate Recognition: We demanded a formal public acknowledgement with attached evidence that His Excellency Mr. Kidima Mubarak be recognized as the Founder, Managing Director, and Sole Trader of the Matooke project introduced from "Alkebulan" into Australia.

23. **FINANCIAL RESTITUTION AND ROYALTIES:** We condemned the bad culture of appropriating Indigenous ideas without compensation, which must cease. We demanded that a Special Committee be established immediately to calculate and grant His Excellency Mr. Kidima Mubarak a shareholder percentage of the proceeds from every kilogram of Matooke imported into Australia since 2015, to the present day and continuing into the future. We have been waiting but all in vain.

24. **COMPENSATION DEBT:** We stand firm that the compensation is a debt owed for the vision His Excellency Mr. Kidima Mubarak pioneered. We have been waiting for the payments, but all in vain.

25. **ACCOUNTABILITY:** We demand that the exploitation of His Excellency Mr. Kidima Mubarak's work must end. He is a humble servant to the community, and we insist on his right to enjoy the fruits of his God-given common sense and vision. The payments must begin with no strings attached, effective immediately.
