RECITALS AND BACKGROUND:

Reference is made to prior formal complaints regarding the non-receipt of financial contributions and cheques generated in the name and title of His Excellency Mr. Kidima Mubarak, leader of the (IGMV).

It was previously directed by the Public that His Excellency Mr. Kidima Mubarak should focus on his health condition and his duties under "The Independent Global Movement Voice (IGMV)" in the best interest of the Global Community, rather than seeking conventional employment. Nevertheless, the (IGMV) is also a permanent position.

SECTION I: STATEMENT OF FACTS AND NOTICE OF NON-RECEIPT OF FUNDS:

I direct the reader to concentrate on my health condition and file an Independent report in the best interest of the Global Community.

The essence of this Communication serves to formally notify the Global Community that, to date, His Excellency Mr. Kidima Mubarak has received no funds from these contributions intended to secure his well-being and a better future. His Excellency was neither formally notified, consulted under his name and title.

It is suspected and alleged that several cheques are currently in the possession of dangerous criminal suspect David, who resides at 32A Mundford Street, North Beach WA 6020. Other cheques are suspected to be held with Princess Khadija Lalla of Morocco, as well as within the Kingdom of Saudi Arabia, the State of Uganda, the Russian Federation, and the Kingdom of Brunei Darussalam.

I am deeply disappointed with the public and the Global Community for allowing a group of individuals from the establishment camp to steal all my money on your watch, despite knowing full well that I am subjected to forced isolation by David in connivance with his administration and the State of Australia. If these allegations are true, all above-mentioned individuals have committed serious crimes of forgery and theft, stealing from His Excellency Mr. Kidima Mubarak and the public.

SECTION II: DECREE REGARDING RECOVERY OF FUNDS AND ARRESTS:

I reaffirm my previous Decree: the public "must" rise up and immediately confiscate all cheques and funds from this group of thieves before it is too late. They have been playing cheap political games to buy time and demand illegal apologies, which are completely irrelevant to the cheques and humble contributions made to your Global Leader (IGMV) in pursuit of happiness and a better future for His Excellency Mr. Kidima Mubarak.

These individuals are hell-bent on ensuring that, His Excellency Mr. Kidima Mubarak dies a slow and painful death after being poisoned and due to their bad culture of envy, malice, and personal vendettas, which are entirely without reasonable justification.

I demand the following:

All suspects must be arrested immediately.

All cheques containing funds must be handed over directly to His Excellency Mr. Kidima Mubarak with no strings attached. The handover "must" be accompanied by a formal cover letter confirming the delivery of all cheques, which shall be signed upon receipt by His Excellency Mr. Kidima Mubarak at



his residence (30A Mundford Street, North Beach WA 6020) within two (2) days without fail following receipt of this Supreme Formal Decree.

Upon receipt, a formal letter acknowledging the cheques **"must"** be published to the public by His Excellency Mr. Kidima Mubarak in appreciation.

Make no mistake: it is mandatory that all money raised from the public as a humble contribution to the leader of the (IGMV), His Excellency Mr. Kidima Mubarak, **"must"** be handed over to him with no strings attached or excuses. Failure to comply **"must"** result in the immediate arrest of the suspects without fail.

I demand that the public intervene to enforce this Supreme Formal Decree, ensuring that all money and cheques are fully recovered and delivered solely to His Excellency Mr. Kidima Mubarak. These funds were intended exclusively to support His Excellency Mr. Kidima Mubarak—not for theft, weddings, loans, or government budgets. Anyone found misusing these funds under such illegal categories shall automatically be considered a **"thief and a criminal"**.

If the money intended for the Global Leader His Excellency Mr. Kidima Mubarak was stolen by unauthorized individuals, then, immediate legal action and arrest **"must"** be taken against the Banks and all financial institutions involved in the theft of my funds, which were humbly contributed by the public to ensure my safety and happiness.

SECTION III: HUMAN RIGHTS VIOLATIONS AND ILLEGAL SURVEILLANCE:

It is abundant clear that existing treaties are being ignored and institutions rendered irrelevant.

I reaffirm my previous Decree: there is nothing for me to apologize about, as **"illegality can never be considered legal"**. David, a dangerous criminal suspect, and his associates have committed crimes over many years through unauthorized activities. Specifically, no valid surveillance device or espionage warrant has ever been lawfully operating, making their actions a direct breach of the Human Rights Act, Article 12 of the Universal Declaration of Human Rights, and Article 17 of the International Covenant on Civil and Political Rights.

Exposing my body to the public around the globe on your watch is strictly illegal. I demand the immediate arrest of David at 32A Mundford Street, North Beach WA 6020, as well as his family members residing at 28 Mundford Street, North Beach WA 6020.

The United Nations and the State of Australia are liable for criminal negligence in favour of the offenders—specifically David and his family (including Ben Kaiser, Bruce, and others), who are considered a group of criminal suspects at 28 Mundford Street, North Beach WA 6020. Their illegal activities, including infringing upon my private life with impunity and engaging in global espionage on your watch, are unlawful.

SECTION IV: REJECTION OF HARASSMENT AND PROTECTION AGAINST EXILE:



I reaffirm my previous decree for the **immediate arrest** of these individuals to serve the justice of our cause. I strongly reject with authority and on principle any harassment and illegal demands that I should apologize to such criminal suspects.

Those responsible for illegal activities—including harassment, unauthorized surveillance, zooming into my residence, and pouring blood at my house—**must be arrested**. Their activities have occurred without my consent and have caused severe anguish, discomfort, cruel, inhuman, or degrading treatment, harm, and violations of my culture, religion, and fundamental human rights.

Furthermore, I reaffirm my previous statements: settlers in Australia have no legal mandate to exile a Black person from Australia. Such illegal actions constitute unconstitutional and treasonous acts. History teaches us that Australia is, and always will be, the land of the First Black Indigenous People—our ancestors. No one has the right to exile His Excellency Mr. Kidima Mubarak from Australia against his will. Those who harbor such intent will be treated as kidnappers and foreign agent assassins, and immediate, unhesitating action will be taken against them without mercy.

SECTION V: INTERNATIONAL COURT DEMANDS:

Please be reminded that there is a case filed with the International Criminal Court (ICC) and other international bodies against the State of Australia and other entities. If you have any legitimate concerns regarding me, they must be formally included in your legal response submissions to the International Courts, rather than continuing to commit offenses of fabrication and harassment that are largely irrelevant. I demand that this culture of misleading the public and tarnishing my good reputation out of envy and malice must cease immediately.

I demand that the International Criminal Court must issue an immediate warrant of arrest against David, residing at 32A Mundford Street, North Beach WA 6020, for:

Harassment, torture, and murder; Defamation and stealing my cheques (contributed by the Global Community) without authorization; Repeated breaches of court orders, perjury, and crimes against humanity; And any additional charges deemed necessary based on offences well known to you and the State of Australia.

Furthermore, the International Criminal Court **"must"** compel the State of Australia to immediately halt all illegal actions committed by David and his family against me and other foreign states.
