SUPREME FORMAL DECREE AND DECLARATION FOR IMMEDIATE ARREST.

"THE INDEPENDENT GLOBAL MOVEMENT VOICE (**IGMV**) IS A REFORM AND MONITORING MOVEMENT IN THE BEST INTEREST OF THE GLOBAL COMMUNITY, **AND IS HERE TO STAY** UNDER THE LEADERSHIP OF HIS EXCELLENCY MR. KIDIMA MUBARAK AS FOUNDER, PRESIDENT, AND CHAIRMAN."

SECTION I: MANDATE AND INDEPENDENCE OF THE (IGMV):

I, His Excellency Mr. Kidima Mubarak, Founder, President, and Chairman of the Independent Global Movement Voice (**IGMV**), solemnly affirm that since the establishment of the (**IGMV**), there is now a good deal of happiness and service delivery at the United Nations. The positive results illustrate very clearly that His Excellency Mr. Kidima Mubarak is an effective performer and reformist, and very soon the world will be a better place to live in under his leadership.

I reaffirm my position that the (**IGMV**) is truly Independent and is not a "**Business Empire.**" It is primarily based on reforming the United Nations and global institutions in the best interest of the Community. His Excellency Mr. Kidima Mubarak does not need to be a wealthy person to justify his effective leadership. He always endeavours to ensure that our global Communities are happy based on God-gifted talent and Common sense. The current situation at the United Nations clearly illustrates my point, and I will never give up fighting for the global community until my last breath, pursuant to **Article 29 of the Universal Declaration of Human Rights (UDHR).**



I also reaffirm my position that nobody will ever interfere with my movement (IGMV), and no one has the right to advocate on my behalf without my consent. Anyone found acting contrary to my principles will be arrested and charged in accordance with national and international law, pursuant to [Article 12 of the Universal Declaration of Human Rights \(UDHR\)](#) and [Article 17 of the International Covenant on Civil and Political Rights \(ICCPR\)](#).

SECTION II: PROPOSED REFORMS AND UNITED NATIONS SUBMISSIONS:

I am very proud of my ideas, which were submitted under the (IGMV) to the United Nations Security Council, United Nations organizations, the European Union/Parliament, and the [Alkebulan Commission/Parliament](#). These proposals mandate that there "must" be "Executive Free Houses" for each and every person across the globe, as well as "Free Commercial Vehicles," based on the model of recycling across the globe pursuant to [Articles 1, 2, 17, and 25 of the Universal Declaration of Human Rights \(UDHR\)](#).

There "must" be an end to wars, and peace and unity "must" prevail in the best interest of the Global Community. I made it very clear in my previous Decree that, you cannot start or continue fighting without the consent of His Excellency Mr. Kidima Mubarak under his leadership of the Independent Global Movement Voice (IGMV). It is evident that His Excellency Mr. Kidima Mubarak has already submitted more than [67 submissions](#) to the United Nations and the European Union Parliaments in a short period of time, fighting for the Global Community in pursuit of happiness and a better future.



Unfortunately, the United Nations process is still lacking, which is the reason why our beloved Global Community is still waiting for their "Executive Free Houses"—all in vain, in direct contravention of Articles 1, 2, 17, and 25 of the Universal Declaration of Human Rights (UDHR). I issued a Decree advising the United Nations, the European Union, and others that the project "must" be funded by available resources within state and kingdom budgets derived from our God-given land, mineral resources, petroleum, oil, gas, etc.

Another decree issued was that every state and kingdom across the globe "must" set up mechanism through Sovereign Banks and provide a 60% guarantee back to the people across the Global Community. Everything is possible, and I do not see any reason for delaying the process based on all the details mentioned above.

SECTION III: ALLEGATIONS REGARDING UNAUTHORIZED PANELS, DEFAMATION, AND SURVEILLANCE:

Further Clarification: I categorically confirm that I have never had any conversation with, nor authorized, a dangerous criminal suspect by the name of David—the driver of a white Jeep with registration REG. 1 HLY.871, who resides at 32A Mundford Street, North Beach WA 6020—to set up a panel.

I suspect that there is a panel set up by David, a dangerous criminal suspect conniving with other groups suspected to be part of the Establishment camp. They have been using their "panel" to tarnish my good reputation, hell-bent on ensuring that I am completely destroyed and that my movement (IGMV) is taken over by the same criminal suspect, David.



He has been defaming me in a deeply dehumanizing manner (**stripping me of my dignity**) by showing my body parts and full body across the globe without my consent. This same Criminal suspect, David, has been televising deceased ancestors without my consent, having never notified me nor obtained my consent for any of his televised materials. This is in direct contravention of:

Article 5 of the Universal Declaration of Human Rights (UDHR);

Article 7 of the Rome Statute of the International Criminal Court (ICC);

Article 12 of the Universal Declaration of Human Rights (UDHR); and

Article 17 of the International Covenant on Civil and Political Rights (ICCPR).

The State of Australia, the United Nations, the European Union, **the Alkebulan Commission**, and the International Criminal Court **"must"** be held accountable for their deliberate refusal to protect me from dangerous Criminal suspects under **Article 1 and 68 of the Rome Statute of the International Criminal Court**.

SECTION IV: DEMAND FOR REMOVAL OF ICC OFFICIALS AND FINANCIAL RECOVERY:

I demand the immediate removal of the President of the International Criminal Court, Judge Tomoko Akane; Vice-President Judge Rosario Salvatore Aitala; Second Vice-President Judge Reine Alapini-Gansou; and Prosecutors of the Court under **Article 46 of the Rome Statute of the International Criminal Court (ICC)**, for Negligence, proof of serious misconduct, severe failure of official duties, total inability to perform their functions, and failure to protect a victim and witness of the court, (**His Excellency Mr. Kidima Mubarak**), resulting in my dignity being stripped by a dangerous Criminal suspect David and my fundamental human rights being violated with impunity on your watch.



Furthermore, the same Criminal suspect, David, has been taking money from the Global Community using the so-called suspected panel under my name and title without my consent, having never notified me nor surrendered the money to me. It is also suspected that the same Criminal suspect, David, has been sharing this money with His Excellency Mr. Vladimir Putin of the Russian Federation, Princess Khadija Lalla of the Kingdom of Morocco, and others.

They have been imposing unreasonable and unnecessary conditions to frustrate the process, insisting that I should apologise before receiving my money. This demand is completely irrelevant because the money consists of direct contributions from the Global Community to His Excellency Mr. Kidima Mubarak, leader of the (IGMV), with no strings attached. More importantly, I have nothing to apologise about.

Their actions reflect a bad culture driven by selfishness, envy, and thieves who are stealing from a global leader, His Excellency Mr. Kidima Mubarak. They act knowing very well that the Global Community made it clear that their contributions are for the leader and that they want me to be happy without being harassed by David and Mr. Putin that, I should go look for work.

The Global Community contributed many times simply because they don't want me look for jobs, instead, allowing me to focus on serving the global Community under (IGMV), which is a permanent position at the same time looking after my health without difficulty. It is a shame that these individuals chose to behave in such an uncivilized manner by stealing all the money contributed by the Global Community.



SECTION V: DEMANDS FOR IMMEDIATE ACTION AND PEACEFUL DEMONSTRATION:

I strongly demand that their cheap political games cease immediately and that the United Nations **"must"** compel them to surrender the money immediately, with no strings attached or excuses, to the rightful owner, His Excellency Mr. Kidima Mubarak, at his residence: **30A Mundford Street, North Beach WA 6020**. Failure to comply **"must"** result in immediate arrest. There **"must"** be no more playing games with the funds humbly contributed by the Global Community toward their leader.

Furthermore, the United Nations **"must"** compel the dangerous Criminal suspect, David, to hand over all televised recordings about me immediately to His Excellency Mr. Kidima Mubarak upon receipt of this Decree.

In addition, our beloved Global Community **"must"** intervene and follow up regarding the funds contributed through Swiss banks, Saud Arabia Kingdom, Uganda, Bahrain, Brunei Darussalam Kingdom and Central bank. These institutions **"must"** be compelled to issue formal statements to His Excellency Mr. Kidima Mubarak and to the public regarding this serious matter.

Furthermore, I demand that our beloved Global Community intervene to enforce this order to ensure that these individuals can never steal from the public again and **"must"** surrender the money immediately to His Excellency Mr. Kidima Mubarak in peace. They should be put on notice that selfishness, envy, Stealing, and bullying have no place in a civilized society.

The days of making unnecessary excuses are over. They **"must"** comply and surrender regardless of their status, bitterness or face imprisonment. There are no instructions from the Global Community to justify their illegal actions,
