SUPREME FORMAL DECREE FOR SPECIAL PUBLIC STATEMENT FROM A GLOBAL LEADER OF (IGMY).

Official Clarification: Regarding Unauthorized Global Fundraising Campaign

FOR IMMEDIATE RELEASE:

This Supreme formal Decree and statement is issued to provide necessary clarification to the general public, international supporters, and the Global Community regarding a suspected recent fundraising campaign conducted under my name and likeness without my prior knowledge, consent, or authorization.

OFFICIAL DECLARATIONS:

DISAVOWAL OF FUNDS: I categorically confirm that I have not received any financial compensation, proceeds, or remuneration from this global fundraising initiative.

UNAUTHORIZED USE OF LIKENESS: The campaign in question was initiated, managed, and executed entirely without my involvement or oversight. The utilization of creative content for financial solicitation was completely unauthorized.

ACCOUNTABILITY AND SUSPECTED MISAPPROPRIATION:



There is strong reason to suspect that the total capital accumulated through this public initiative was entirely intercepted and misappropriated by a single individual identified as David who resides at address: 32A Mundford Street, North Beach WA 6020.

NOTICE TO THE PUBLIC: This announcement serves as an official confirmation to all global contributors that none of the donations intended to support or recognize my work have reached me.

CLOSING REMARKS:

I deeply appreciate the continued support of the public and feel it is my administrative responsibility to ensure absolute transparency regarding this matter. Further steps will be determined to address the unauthorized commercial exploitation of my content. My humble appeal to the Public/Global Community is that, if it's true, then, **please intervene and rescue the funds from this dangerous Criminal Suspect David.**
