SUPREME FORMAL DECREE AND ORDER OF ABSOLUTE EXCLUSION, NON-INTERFERENCE, AND CEASE-AND-DESIST MANDATE:

Reference is made to my previous Decrees establishing that you cannot continue infringing upon my private life with impunity.

By virtue of the powers entrusted to me by the Almighty God **"Allah"** and in strict accordance with the sovereign authority and in accordance with the principle of **"Universal Human Rights, Justice and International Equity"**, this Decree formally submits a Supreme demand to the United Nations General Assembly, the UN Security Council and the broader Global Community.

I, His Excellency Mr. kidima Mubarak, **"Leader, Founder, President, and Chairman of the Independent Global Movement Voice (IGMV)"**, hereby solemnly affirm and declare with full authority and demand for immediate absolute Exclusion, Non-Interference, and Cease-and-Desist **with Veto Power**.

RECITALS AND MANDATE JURISDICTION:

WHEREAS, The Independent Global Movement Voice (**IGMV**) operates as an independent, autonomous global organization established to promote unity, peace, happiness, and universal human rights across the global community; and

WHEREAS, the organizational integrity, intellectual property, private affairs, and personal governance of the Founder and Leadership of (**IGMV**) require absolute protection from unauthorized interference, defamation, and public exploitation under international privacy standards.

DIRECTIVE OF EXCLUSION AND NON-ACCESS:

IT IS HEREBY DECREED AND ORDERED THAT.

Absolute Denial of Access: Any individual, entity, or party who has not received explicit written permission from the Founder/Leadership of (**IGMV**) is strictly prohibited and barred from accessing, joining, representing, or



participating in any proceedings, digital platforms, physical forums, or operational networks of the (IGMV).

Prohibition of Unauthorized Representation: No individual or unauthorized third party shall claim authority, speak on behalf of, or issue statements in connection with IGMV or its leadership regarding any matter pertaining to the Global Community.

MANDATE OF NON-INTERFERENCE AND CEASE-AND-DESIST:

Injunction against Public Discussion: All unauthorized individuals are hereby directed to cease and desist immediately from initiating, publishing, broadcasting, or engaging in public discussions concerning the private life, personal security, or direct affairs of the (IGMV) Leadership.

Protection of Dignity and Privacy: Pursuant to **Article 12** of the Universal Declaration of Human Rights and **Article 17** of the International Covenant on Civil and Political Rights, no person shall be subjected to arbitrary interference with their privacy, family, home, or correspondence, nor to attacks upon their honour and reputation.

Protection of International Deliberations: Matters pertaining to global peace, international decrees, and diplomatic strategies formulated by (IGMV) shall remain free from external harassment, defamation, or unauthorized interference by non-sanctioned actors.

ENFORCEMENT AND CONSEQUENCES OF NON-COMPLIANCE:

Failure to abide by this Order of Exclusion and Non-Interference—including any continued unauthorized discussion, harassment, or attempt to breach (IGMV) operational boundaries—shall result in immediate referral to

relevant legal, administrative, and jurisdictional authorities for formal injunctive relief, sanctions, and enforcement.
