This document serves as a formal notice regarding Global Contribution's fund and financial assets intended specifically for my personal support, welfare, and future Security, personal benefit, well-being as an individual.

1. OBJECTIVE AND PURPOSE:

This document serves as an official representation to notify relevant administrative and regulatory bodies within the United Nations system regarding allegations of wide-scale financial impersonation, identity theft, and the unauthorized solicitation of digital assets and Cryptocurrency under the identity of the "Global Leader" of the Independent Global Movement Voice (IGMV).

2. STATEMENT OF ISSUES:

That the **Secretariat** log this **administrative representation** regarding identity impersonation and global financial misrepresentation. That relevant anti-fraud and cybercrime monitoring frameworks (**such as the UNODC**) take note of these unverified solicitations. That standard procedures for administrative Communication between non-governmental leadership and official international organs be clarified.

That any **recovered assets,funds**,identified as personal Contributions be transferred directly to His Excellency Mr.Kidima Mubarak, **"Global Leader"** Founder,President,and Chairman of the **Independent Global Movement Voice (IGMV)** as the rightful owner. Or be handed over to the International Criminal Court (**ICC**),and the Court immediately send the Funds to His Excellency Mr.kidima Mubarak,Founder,President,**Global Leader**, and Chairman of the **Independent Global Movement Voice (IGMV)**.

Furthermore, I demand that the Global Community **"must"** intervene in this operation and play your part so that the individuals as mentioned above
