**SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE PAY OF MY COMPENSATION IN REGARDS TO OPTUS DATA BREACH CLAIM 2022.**

I am writing to formally request an immediate status update regarding my registered claim for the **"2022 Optus Data Breach"**. For your records and context, below is a summary of the key communications and notices regarding this matter:

**18 October 2022:** Notification received from Optus confirming my personal information was compromised in the **September 2022** cyberattack.

**9 November 2022:** Confirmation received from Maurice Blackburn Lawyers acknowledging receipt of my verified contact details for the representative complaint.

**26 March 2024:** Update received from Maurice Blackburn Lawyers regarding the Federal Court decision of **1 March 2024** concerning the Office of the Australian Information Commissioner (**OAIC**).

**28 August 2024:** Formal inquiry sent by me to **"Maurice Blackburn Lawyers"** requesting an update on compensation distribution.

**4 November 2024:** Follow-up email sent by me seeking an urgent response regarding my claim status.

**14 August 2025:** Final update received from **"Maurice Blackburn Lawyers"** regarding civil penalty proceedings initiated by the (**OAIC**) against Optus. **Unfortunately, Since then, "I haven't been paid"** nor be advised about my claim.

**REQUEST FOR ACTION:**

As I have received no further updates **since August 2025**, please provide written clarification on the following within five (5) business days:

**Current File Status:** Confirmation of my active registration status within the representative complaint.

**Procedural Update:** The current status of the (OAIC) proceedings and whether any settlement or Compensation framework has been determined by the court.

**Next Steps:** I demand that my money **"must"** be paid immediately, failure to comply within the specified time within (5) days, then those responsible **"must"** be arrested and be charged in accordance with International Law.
