SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE SUSPENSION OF URANIUM, ALL MINERAL EXPORT AND TRADE TERMINATIONS BETWEEN RUSSIA FEDERATION, UGANDA STATE AND ACROSS ALKEBULAN.

By virtue of the powers entrusted to me by the Almighty God "Allah" and in strict accordance with the Sovereign mandate set forth in the Independent Global Movement Voice (IGMV),

I, His Excellency Mr. Kidima Mubarak, Founder, President, Global Leader, and Chairman of the Independent Global Movement Voice (IGMV), hereby formally declare and affirm that, His Excellency Mr. Vladimir Putin is not a friend of "Alkebulan" rather a businessman Opportunist.

1. DECLARATION OF TERMINATION:

Effective immediately, all trade agreements, maritime transit permits, and export authorizations regarding strategic minerals—including raw pitchblende, uranium ore, all minerals and rare earth elements—consigned to the designated state of the "Russia Federation" are indefinitely revoked.

2. STATEMENT OF GROUNDS:

Border Containment: Customs and border authorities are directed to impound all outbound shipments attempting to bypass this order.
