NOTICE AND DEMAND:

Justification of Delays: A clear breakdown explaining why implementation has not occurred within the expected timeframe.

Binding Timeline: A concrete, date-specific schedule outlining the exact steps that will be taken to execute each outstanding item.

Designated Point of Contact: The name and direct contact information of the administrator responsible for overseeing this execution.

NOTICE OF INTENT:

Failure to provide the requested report within the specified timeframe will be interpreted as a failure of administrative duty. Should this matter remain unresolved, further formal escalations and appropriate legal or regulatory remedies will be pursued immediately without further warning.
