**SUPREME FORMAL DECREE AND DEMAND REAFFIRMING PREVIOUS

By virtue of the powers entrusted to me by Almighty God "Allah" and in the name of Allah, I reaffirm my previous decision for the immediate removal of Princess Khadija as Vice-President of the (IGMV) and as Senior Next of Kin. Such decree automatically revoked her Power of Attorney, dated Tuesday, 23 June 2026, under reference code REF: KM/IGMV/62/23/06/2026. I provided formal reasons for this action, part of which pertained to the fact that they never responded to my official communications nor confirmed the appointment.

SECTION I: INVESTIGATION AND SANCTIONS:

I solemnly affirm and declare that, from that very day, Princess Lalla Khadija's "Power of Attorney" was revoked, and a decree was issued ordering an immediate investigation into her communications and contact with dangerous Criminal suspect David and his family.

Furthermore, an immediate explanation was demanded as to why the suspects have never been arrested nor removed from the property adjacent to my residence to a distance of at least 500 meters, as per my previous formal demands.

I categorically affirm and declare that Princess Lalla Khadija will never be recognized by me, nor will she ever be part of my family. I regret introducing her to the public. She "must" stay completely away from my life. Keep in mind that illegality can never be considered legal.

SECTION II: DEMAND FOR RECOVERY OF STOLEN FUNDS:

I demand that all funds contributed by the Global Community in support of my better future—which were stolen by Princess Lalla Khadija and David Gallagher—"must" be paid directly to me immediately, before it is too late.

I remind the United Nations and its Team, the European Union Commission, the Alkebulan Commission, and the general public/Global Community that it is your absolute responsibility to compel Princess Lalla Khadija and David Gallagher to ensure that all money contributed by the Global Community is fully refunded directly to me immediately with no strings attached.

Failure to comply "must" result in immediate legal action being taken against Princess Lalla Khadija and David Gallagher for stealing from me and the public.

SECTION III: BINDING DECLARATION AND EXECUTION:

Please note that this Decree serves as a legally binding declaration. Let all authorities, governments, and international bodies take formal notice of this final Decree.
