SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE "CITIZEN'S ARREST" UNDER SPECIAL ASSIGNMENT WITH FULL AUTHORITY FOR THE RECOVERY OF STOLEN FUNDS EXCEEDING 4 TRILLION DOLLARS, FOLLOWED BY IMMEDIATE, PROSECUTION, AND CONVICTION.

CITIZEN'S ARREST ORDER:

ALL GLOBAL COMMUNITY ACROSS THE GLOBE "YOU ARE HEREBY ORDERED" TO ARREST THE PERPETRATORS INVOLVED IN STEALING MY MONEY CONTRIBUTED BY THE GLOBAL COMMUNITY REGARDLESS OF THEIR STATUS.

By virtue of the powers entrusted to me by Almighty God "Allah," and in strict accordance with the principles of Universal Human Rights, Justice, Sovereign Authority, International Law, and Equity, this Decree formally Submits a Supreme Demand to the United Nations General Assembly, the United Nations Security Council, and the broader Global Community.

I, His Excellency Mr. Kidima Mubarak—Founder, President, Global Leader, and Chairman of the Independent Global Movement Voice (IGMV)—hereby Solemnly affirm and declare with full authority that the Global Community across the Globe have been ordered, with immediate "Veto Power", to investigate, arrest and recover all funds exceeding four (4) trillion dollars Contributed by the "Global Community" for the future and well-being of His Excellency Mr. Kidima Mubarak,

A bad Culture of deliberately disobeying orders and directive of a “Global Leader” His Excellency Mr. Kidima Mubarak, thus Committing Serious Misconduct and Miscarriage of Justice “must”

cease with immediate effect. Due to systematic bias, Institutional Cover-up and Conflict of interest within the **International Criminal Court (ICC)** that favour the Perpetrators, my prior Complaints have been unfairly Ignored by Clever racist as **“rhetoric without evidence”** I treat this negligence as Institutional bullying an offence against human dignity, and direct infringement upon fundamental rights.

WHEREAS, the Independent Global Movement Voice (IGMV) operates as an independent, autonomous global Movement established to promote unity, peace, prosperity, happiness, and universal human rights across the Globe;

WHEREAS, the integrity, intellectual property, private affairs, and personal governance of the Founder and Leader of (IGMV) require absolute protection from unauthorized interference, defamation, and public exploitation under International standards of private law;

Prohibition of Unauthorized Representation:

Pursuant to

REF/KM/IGMV/84/30/2026.dated Saturday 30th August, 2026, and Reference KM/IGMV/76/19/08/2026, dated Wednesday, August 19, 2026,

I issued a Supreme Formal Decree establishing that no individual or unauthorized party shall claim authority, speak on behalf of, or issue

Statements regarding **(IGMV)** or its leadership on any matter pertaining to the Global Community. Therefore, **David, Princess Lalla Khadija, His Excellency Mr. Vladimir Putin** and others are not allowed to represent me or **(IGMV)** in any form and **“must”** be arrested.

Prohibition of Public Discussion: All unauthorized individuals are hereby ordered to cease and desist immediately from initiating, publishing, broadcasting, or engaging in public discussions concerning the private life, personal Security, or internal affairs of **(IGMV)** leadership. I reaffirm my previous Decrees that **David and others** as mentioned above are not appointed anywhere and they don't have my Consent to represent **(IGMV)** and will never be part of **(IGMV)** as far as I am Concerned.

Protection of Dignity and Privacy: Pursuant to **Article 12** of the Universal Declaration of Human Rights **(UDHR)** and **Article 17** of the International Covenant on Civil and Political Rights **(ICCPR)**, no person shall be subjected to arbitrary interference with their privacy, family, home, or Correspondence, nor to unlawful attacks upon their honour and reputation.

These individuals have repeatedly defied explicit **Cease and Desist** orders through ongoing harassment, obstruction of justice, **financial theft**, and acts driven by malice and greed.

Furthermore, they Continue to unlawfully misappropriate funds Contributed by the Global Community.

This special assignment authorizes full power to ensure the Complete recovery of all funds exceeding four (4) trillion dollars and to guarantee that all Suspects are prosecuted under national and International law, regardless of their position.
