SUPREME FORMAL DECREE AND DEMAND WITH IMMEDIATE MANDATORY RELEASE OF HIS EXCELLENCY MR. NICOLAS MADURO, FIRST LADY CILIA FLORES AND HIS EXCELLENCY RODRIGO DUTERTE UNDER A BLANKET OF AMNESTY.

By virtue of the powers entrusted to me by Almighty God "Allah," and in strict accordance with sovereign authority, the principles of Universal Human Rights, and International Law, this Decree formally submits a Supreme Demand to the United Nations General Assembly, the UN Security Council, the United States of America, and the broader Global Community.

I, His Excellency Mr. Kidima Mubarak—Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV) and Chairman of Alkebulan—Solemnly affirm and declare with full authority the demand for the immediate, mandatory release of the Excellencies as mentioned above, with immediate "Veto Power".

This demand and authority is primarily based on the Universal Declaration of Human Rights and International Law, specifically Articles 1, 2, and 29(1) of the Universal Declaration of Human Rights.

Background Regarding His Excellency Mr. Nicolas Maduro:

By way of background, it is established that His Excellency Mr. Nicolas Maduro (age 63) was unlawfully abducted in a middle-of-the-night raid in early January 2026 and was taken to New York, United States of America, against his will.

The illegal abduction was in direct violation of Articles 1 and 2 of the United Nations Charter and Diplomatic immunity under the Vienna Convention on Diplomatic Relations.

His Excellency Mr. Nicolas Maduro is entitled to conduct-based sovereign immunity. He vehemently denied all allegations against him as false, Considering his capture an act of kidnapping and himself a prisoner of war. He Serves as the Head of State of a sovereign nation well-recognized by the United Nations and the "Independent Global Movement Voice (IGMV)".

Heads of State enjoy Complete immunity; therefore, the United States is in violation of Diplomatic Standards, jurisdiction, and international law. A President is absolutely immune from Civil and Criminal prosecution for all acts Committed within the official duties and "outer perimeter" of office.

Article 2(7) of the United Nations Charter prohibits the UN from intervening in matters that fall within the domestic jurisdiction of any State. Furthermore, regarding the prohibition of force, members "must" refrain from the threat or use of force against the territorial integrity or political independence of any country.

The attack on Venezuelan soil was an act of aggression, a breach of peace and security, and an unjust violation of international law, including Article 1 of the UN Charter, human rights, national integrity, and culture.

Article 2(3) and 2(4) state that all members shall settle international disputes by peaceful means in Such a manner that international peace, Security, and justice are not endangered. All members "Shall" refrain in their international relations from the threat or use of force against the territorial integrity or political independence of any State.

The military raid was authorized by His Excellency President Donald Trump and His



Excellency President Nicolas Maduro has been held against his will in the Brooklyn Federal Jail and is scheduled to go on trial in June 2027. United Nations Diplomatic agents stationed in Venezuela at the time, suspected to have spied on the State thus violated articles of the Vienna Convention on Diplomatic Relations.

There can never be legitimate charges brought against His Excellency Mr. Maduro prior to June 2027, and any such charges “must” be considered a “miscarriage of justice”. The United States of America violated the UN Charter and the Vienna Convention on Diplomatic Relations during this unlawful detention, rendering the custody illegal.

My instructions dictate that His Excellency Mr. Maduro “must” be released immediately without charges or a Criminal record, allowing him to return to his nation as a free man under a Blanket of Amnesty granted to both parties, including the United States of America, in the spirit of reconciliation, peace, unity, and prosperity.

Upon his return, it is envisaged that he will use this experience as a reformed leader to rebuild his beloved Country by adopting initiatives such as an “Executive Free Housing Programme,” Providing “Free Commercial Vehicles”, and establishing a Diplomatic framework for resource management—specifically a reasonable distribution ensuring national stability, with 20% reserved for the State to maintain stability and attract Global Investors to drive innovation.

20% for Global Investors to drive innovation, and

60% returned directly to the Global Community of each State.



This 60% is a reclamation of God given land, mineral

Resources, gold, phosphate, nickel, Gas, Petroleum and Oil, to mention but a few to provide Executive free Housing.

No human being “shall” be left without dignity. “You cannot accomodate Dogs in the House when your fellow human beings are rotting outside in Cold and Hot weather Conditions without a shelter”. Set free His Excellency Mr. Nicolas Maduro on “age and Compassionate” ground “under a Blanket of Amnesty” to both the accused and the Complainant to ease Commence immediate Construction in Conjunction with “The Independent Global Movement Voice (IGMV)” under the leadership of His Excellency, Mr. kidima Mubarak, Founder, President,

Chairman of Alkebulan, and Global Leader, in the best interest of the Global Community.

The Land and mineral resources—including gold, phosphate, nickel, gas, and petroleum—are part of a “God-given reclamation” to ensure that no human being is left without dignity.

No person should be left unsheltered in harsh Conditions while others live in luxury.

Second Supreme Formal Demand Decree: His Excellency Mr. Rodrigo Duterte:

This Second Supreme Formal Demand Decree mandates the immediate Mandatory release of His Excellency Mr. Rodrigo Duterte (age 81) of the Philippines, who is Currently held at the International Criminal Court (ICC) in the Hague, Netherlands awaiting trial. He was transferred to the ICC on March 12, 2025, regarding his administration's war on drugs.



Based on the Public record, His Excellency Mr. Duterte is regarded as one of the most effective President Philippines has had because during his time as President he built extensive bridges, roads and other Infrastructure and made the people of Philippines safe.

A leader who took decisive action against Crime and illegal drugs to protect his populace should not be subjected to indefinite punishment. He fulfilled his Campaign promises so that Communities Could remain safe, healthy, and prosperous.

I demand with immediate "Veto power" that His Excellency Mr. Dutertes "must" be released on Condition of "age and Compassionate" ground under a Blanket of Amnesty. So that we work together with His Excellency Marcos reconstructing "Executive Free Housing" programme as explained above in the best Interest of the Global Community pursuant to article 1, 2, and 17 of the Universal Declaration of Human Rights.

There "must" be immediate dialogue between His Excellency Mr. Marcos and the Duterte Family for Unity, peace and Prosperity. I believe that His Excellency Mr. Rodrigo Duterte is a changed man who will use this experience serving his beloved Philippines People with one heart.
