SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE MANDATORY (SHUTTING DOWN) OF ALL OFFICES AS LISTED BELOW. DISOLUTION, REVOCATION OF MANDATE, IMMUNITY, AND FORMAL DEMAND FOR RESTITUTION IN THE BEST INTEREST OF PUBLIC INTEGRITY.

MATTERS OF CLARITY AND COMMON SENSE:

Alkebulan, the Global Community, and the "Independent Global Movement Voice (IGMV)" remain fully operational and are entirely exempt from any shutdown, by order and under the Supreme Authority of the Founder, Global Leader, President and Chairman, His Excellency Mr. Kidima Mubarak.

Reference is made in regards to my previous Decrees demanding for recovery of **stolen money (Funds)** exceeding **\$4 trillion Dollars**, Contributed by the Global Community, meant for His Excellency Mr. Kidima Mubarak, Founder, Global Leader, President, Chairman of the Independent Global Movement Voice (IGMV), and **Chairman of Alkebulan**, for which I have been waiting but all in vain.

By virtue of the powers entrusted to me by the Almighty God **"Allah"** and in strict accordance with sovereign authority, the principle of Universal Declaration, Rome statute of the International Court, and International Law, this Decree formally submits a Supreme Demand to the **"United Nations General Assembly"**, the UN Security Council, the International Court of Justice (ICJ), the International Criminal Court (ICC), to Parliamentarians and Judicature as per listed above and the broader Global Community.

I, His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV)** and **"Chairman of the Alkebulan"**. Solemnly affirm and declare with full authority and demand **"with Veto Power"** for immediate mandatory Shutting down of All Offices, organisations, Local and International Courts, and Institutions across the Globe until all Suspects are prosecuted in accordance with International Law, including but not limited to Judicial Officers and Officers of the Courts pursuant to article 46 of the Rome Statute of the International Criminal Court (ICC).

Until all the money (funds) exceeding \$ 4 trillion Dollars of USA is recovered from some individuals as listed below,

- 1. His Excellency Mr. Vladimir Putin of Russia Federation.**
- 2. David Kaiser aka Gallagher of Australia.**



3. Princess Lalla Khadija of Morocco.

Accordingly, Notice is hereby formally served via emails regarding multi-jurisdictional allegations of egregious Serious misconduct—including systemic abuse of office, aiding and abetting identity fraud, misappropriation of assets, Money-Funds exceeding \$4 trillion Dollars, Corruption, Disobeying orders, Abetting Impersonation, theft and Conspiratorial Criminal engagement. Perverting the Course of Justice and abuse of the United Nations treaty, such as Article 1, 2, 12, and 29(1) of the Universal Declaration of Human Rights (UDHR),

Article 17 of the International Covenant on Civil and Political Rights (ICCPR). "Disregard of Human Rights".

Article 5, 6, 7 and 68 of the Rome Statute of the International Criminal Court (ICC). "Denying His Excellency Mr. Kidima Mubarak Protection".

Pursuant to Charges of Serious Misconduct, all administrative authorities, diplomatic privileges, and operational mandates are declared (null and void), demanding the immediate Cessation of organizational activities, full Cooperation with Independent oversight bodies, and the total Surrender of administrative control.

The Independent Global Movement Voice (IGMV) Supports fairness, accountability and standing up against Corruption and Public Integrity.

This formal demand and authority is primarily based on the Universal Declaration of Human Rights (UDHR), the Rome Statute of the International Criminal Court (ICC), International Covenant on Civil and Political Rights (ICCPR), and International Law, specifically Article 1, 2, 12 and 29(1) of

Universal Declaration of Human Rights (UDHR), Article 17 of International Covenant on Civil and Political Rights (ICCPR), and Article 5, 6, 7 and 68 of the Rome Statute of the International Criminal Court (ICC).

Once again, please be reminded that, you have all deliberately failed to protect me and my properties as a witness of the Court and a "Global Leader" in accordance with Universal Declaration of Human Rights (UDHR),



the UN Charter, and **article 68** of the Rome Statute of the **International Criminal Court (ICC)**.

It is evident that you have deliberately refused to comply providing a mandatory formal response from the International Court of Justice (ICJ), the International Criminal Court (ICC), the General Assembly and others in regards to my previous Decrees to recover more than **\$4 trillion Dollars** from Criminal Suspects and others as per listed above.

Furthermore, you have deliberately refused to comply for immediate mandatory formal explanation as to why the International Court of Justice (ICJ), and International Criminal Court (ICC) have not notified me regarding the recovery of those funds. Why the Suspects haven't been prosecuted and charged?.

More importantly, I give power of attorney to my beloved **"Global Community"** with a mandatory authority demanding that, you **"must"** intervene and deal with this **"Complex financial recovery"** situation once and for all in the best interest of Justice and to protect the dignity of your **"Global Leader"** His Excellency Mr. Kidima Mubarak.
