SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE MANDATORY UNCONDITIONAL SURRENDER OF MY MONEY EXCEEDING \$30 TRILLION: FOLLOWED BY ARREST AND PROSECUTION REGARDLESS OF THEIR STATUS.

Reference is hereby made to prior Decrees demanding for immediate Surrender of my money exceeding **\$4 trillion Dollars**, but all in vain.

By virtue of the powers entrusted to me by the Almighty God **"Allah"** and in strict accordance with sovereign authority, the principle of Universal Declaration, Rome statute of the International Court, and International Law, this Decree formally submits a Supreme Demand to the "United Nations General Assembly", the UN Security Council, the International Court of Justice (**ICJ**), the International Criminal Court (**ICC**), to Parliamentarians and Judicature, **Mr. Elon Musk and Satoshi Nakamoto**, in the best interest of the Global Community.

I, His Excellency Mr. Kidima Mubarak, Founder, President, Chairman, and **"Global Leader"** of the **"Independent Global Movement Voice (IGMV)"** and **"Chairman of the Alkebulan"**. Solemnly affirm and declare with full authority and demand with **"Veto Power"** for immediate mandatory Unconditional Surrender of my money-funds exceeding **\$30 Trillion Dollars**, arrest and Prosecution of all usurpers who have been unlawfully infringing upon my private life with Impunity in direct Contravention of **articles 12** of the Universal Declaration of Human Rights (**UDHR**), and **Article 17** of the International Covenant on Civil and Political Rights (**ICCPR**). At the same time Stealing from me and the Public with impunity.

While Simultaneously embezzling funds from me and the public, bear in mind that you are legally obliged to release all funds to the rightful recipient within two days after receipt of this Decree.



It is further suspected that, portions of these funds-money were diverted to finance weddings with the full knowledge of your Agent in Perth Western Australia. It is also suspected that, some funds were directed into the Russian Election Campaign by one of your Agent in Moscow **His Excellency Mr. Vladimir Putin.**

Additionally, It is also suspected that, the Russian Parliament made a decision by chasing away one of the Cheques hidden in Russian so that can be handed over unconditionally to the right full owner His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman, and Global Leader** of the **Independent Global Movement Voice (IGMV)**. Similarly to the one which was chased away by the Italian Parliament unfortunately, none of these recovered money have been remitted to me.

It is also suspected that, some official Statements have been recorded at the Russian Federation Police, International Court of Justice (ICJ) and the International Criminal Court (ICC), in regards to the same Cheques. It is also suspected that some unauthorized funds-money have been sent to the Parliament of **Uganda, Swiss Bank, Yemen and Morocco**, whereby I have never been formally notified.

I hold you accountable for the Torture and Trauma you have caused me during this period of time. I demand that those who have been using my name His Excellency Mr. Kidima Mubarak and a title of **"Global leader"** **"stealing from me"** and the Public without handing over the money to me **"must"** be arrested and be prosecuted immediately, so that it does never happen again.

I demand that all the funds-money exceeding **\$30 Trillion Dollars** contributed by the Global Community, well-wishers, good Samaritans, intended for His Excellency Mr. Kidima Mubarak a **Global Leader** **"must"** be handed over or paid immediately with no strings attached.

Please be advised that, I have pledged towards the Construction of **Executive Free Housing Towers** for the Global Community, particularly targeting the underprivileged and unhoused. Any continued withholding of



my money-funds Constitutes a direct obstruction to these humanitarian projects in the best interest of the Global Community.

Accordingly, I demand that all funds my money **"must"** be surrendered immediately within two days after receipt of this Decree. You cannot continue keeping my money against my will, my fundamental rights as a receiver **"must"** be respected and your office **"must"** send me a formal letter advising where to collect my money from, and then, I will respond with clear guidance on how to surrender immediately without further delay.

Despite to the fact that your Agents have been using my Names and Title of **"Global Leader"**, Collecting money from the Global Community, I have never received any money from you nor from your Agents. They are so jealousy that I am going to be richer than them and they don't want to see a black person richer than them, driven by prejudice and opposition.

I demand for immediate removal and replacement of **David Kaiser aka Gallagher** Agent of Perth Western Australia and **His Excellency Mr. Vladimir Putin** Agent of Moscow Russia to protect the reputation safeguard institutional integrity of **Cryptocurrency** and expedite services delivery.

Furthermore, I demand that those who are executing my Projects approvals under **"The Independent Global Movement Voice (IGMV)"**, without my explicit Consent **"must"** be arrested and be prosecuted in accordance with International Law. I reaffirm my Previous demands that, any project under the Jurisdiction of the **"Independent Global Movement Voice (IGMV)"**, **"must"** all be Inspected, approved and Signed exclusively by His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman** and **"Global Leader"** of the **"Independent Global Movement Voice (IGMV)"**, and **Chairman of the Alkebulan.**

Please note that this Decree serves as a legally binding Declaration. Let all authorities, Governments, Kingdoms, and International bodies take formal notice of this Decree for Immediate Mandatory Surrender of my money-funds, arrest and Prosecution.
