Distinguished Excellencies, VIP Colleagues, and Global Community,

SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE MANDATORY ARREST AND PROSECUTION OF DAVID KAISER GALLAGHER REGARDLESS OF HIS STATUS.

Reference is hereby made to prior Decrees demanding for immediate surrender of my money **exceeding \$4 trillion Dollars and Cease and Desist**, but all in vain.

Multiple breach of Court Orders, Conflict of Interest, and Disobeying my orders BY untouchable Criminal Suspect namely David Kaiser aka Gallagher who have been infringing upon my private life with Impunity in direct Contravention of articles 12 of the Universal Declaration of Human Rights (UDHR), and Article 17 of the International Covenant on Civil and Political Rights (ICCPR). At the same time Stealing from me and the Public with impunity. and,



Article 5, 6, 7 and 46 of the Rome Statute of the International Criminal Court (ICC). Bear in mind that you are obliged to respect the treaties of the United Nations and to respect the integrity of your Offices and the Honourable Court.

It is also expected of you as a mandatory to Protect His Excellency Mr. Kidima Mubarak as a witness of the Court and a Global Leader, including his Properties pursuant to **article 68** of the Rome Statute of the International Criminal Court (ICC).

I demand that, failure to comply with this order to arrest and prosecute untouchable Criminal Suspect David Kaiser aka Gallagher with immediate effect, then, Consider your selves jobless in accordance with **article 46** of the Rome Statute of the International Criminal Court (ICC).

It is also suspected that, some Statements have been recorded at the Russian Federation Police, International Court of Justice (ICJ) and the International Criminal Court (ICC), in regards to the same Cheques. It is also suspected that some money have been sent to the Parliament of Uganda, Swiss Bank, Yemen and Morocco, whereby I have never been formally notified.

I hold you accountable for the Torture and Trauma you have caused me during this period of time. I demand that those who have been using my name His Excellency Mr. Kidima Mubarak and a title of "Global leader" "stealing" from me and the Public without handing over the money to me "must" be arrested and be prosecuted immediately, so that it does never happen again.

Please be advised that, I had made a Pledge of building Executive Free Housing Towers for the Global Community, particularly the Poor and those on the streets (Homeless). Delaying my money is a serious obstruction to my projects and to start building or construction in the best interest of the Global Community.

I demand that my money "must" be surrendered immediately within two days after receipt of this Decree. You cannot continue keeping my money



against my will, my fundamental rights as a receiver **"must"** be respected and your office **"must"** send me a formal letter advising where to collect my money from, and then, I will respond with clear guidance on how to surrender immediately without further delay.

I demand that **David Kaiser aka David "must"** be stopped/Condemned from using my letterhead, Office name and be prosecuted. I also demand that, **"MBE PERTH DESIGNERS" "must"** formally apologise to me for allowing **David Kaiser aka Gallagher** use my Letterhead without my Permission. **"You cannot give away my Letterhead or Stamp without my formal Consent"**.

I demand that those who are signing off on my Projects under **"The Independent Global Movement Voice (IGMV)"**, without my explicit Consent **"must"** be arrested and be prosecuted in accordance with International Law. I reaffirm my Previous demands that, any project under the Jurisdiction of the **"Independent Global Movement Voice (IGMV)"**, **"must"** all be Inspected, approved and Signed exclusively by His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman and Global Leader of the "Independent Global Movement Voice (IGMV), and Chairman of the Alkebulan."**

More importantly, I give power of attorney to my beloved **"Global Community"** with a mandatory authority demanding that, you **"must"** intervene and arrest this untouchable Criminal Suspect, namely, **David Gallagher aka Kaiser** and hand him to the International Criminal Court (ICC).
