REMINDER FOR IMMEDIATE MANDATORY AND “UNSTOPPABLE” GLOBAL JUDICIAL GENERAL ELECTIONS. (5 DAYS REMAINING).

CONTINUATION OF STANDING DIRECTIVES:

First and foremost, I hereby reaffirm my previous Decree: the ongoing global lockdown remains in full force and effect until further notice.

MANDATE FOR GLOBAL JUDICIAL ELECTIONS:

This election is primarily based on giving the Global Community a chance for the first time, the direct opportunity to exercise their inalienable right to select and vote for Judicial Officials based purely on merit, honesty, strict Independence, and principled character—free from Corruption, Racism, Apartheid, Genocide, Bias, Discrimination, and Colonialism.

This mandate is anchored in the Universal Declaration of Human Rights (UDHR), Specifically Articles 2, 4, 7, 18, and 21(3).

PROTECTION OF VOTERS AND HUMAN RIGHTS GUARANTEES:

I demand that, Pursuant to Article 5 of the (UDHR), no Global Community should ever be intimidated, tortured, or subjected to cruel, inhuman, or degrading treatment for exercising their Inalienable right to choose and vote better judicial Officials or Candidates of their choice.

Furthermore, as stipulated under Article 30 of the Universal Declaration of Human Rights (UDHR), prohibits State Officials destruction of any of the rights and fundamental freedoms set forth in the Declaration of Human Rights.

CANDIDATE QUALIFICATIONS AND PUBLIC TRANSPARENCY:

I demand that, Pursuant to Articles 6, 7, and 19 of the Universal Declaration of Human Rights (UDHR), all Candidates “must” publish their Curriculum Vitae (CV) in the public domain for recognition, perusal and global review:

I strongly encourage you to focus on electing New Judicial Officials because this election is for the “Global Community” (the public) exercising your fundamental rights to choose the best Judicial Officials who are



Community oriented and then change the System in the best interest of your Children and Grandchildren's better future.

Please reclaim your Inalienable rights and freedom based on **Common Sense** and Human Rights Values. **"No Experience required"**.

Academic Credentials: A Degree or Master's in Law.

Character Requirements: High moral character recommended by the local Community, unquestionable honesty, Strict Independence, Community orientation, and Common sense. **Prior formal judicial experience is not required.** Victims of torture are highly encouraged as Candidates.

Criminal Record: Candidates **"must"** have no Criminal record.

Campaigning Prohibitions: Financial and political Campaigning is Strictly Prohibited. Candidates need only publish their Credentials; Selection rests entirely with the Global Community.

ELECTION TIMELINE AND ADMINISTRATION:

Voting Period: Commenced on **Friday, 18th September 2026**, and Concludes **Friday, 2nd October 2026 (Afternoon)**.

Judicial Official Candidates are **strictly prohibited from Fiscal Campaign**, after publishing their Papers for review, then, the rest is for the Global Community to decide. **There will never be Preferences in this election. This is not a Political Campaign election, we are dealing with the matter of Justice, fairness and Law.**

Term of Office: Elected Judicial Officials shall serve a non-preferential **4-year term, until the next elections**, with the winner determined by **4% votes Counted** following the official tally.

Final Ratification: I demand that a list of all elected Judicial Officials **"must"** be submitted to my office via email immediately after the election for final approval. My decision and a decree for this General Judicial Election is primarily based on **Articles 1, 2, and 29(1)** of the Universal Declaration of Human Rights (**UDHR**). **(ENFORCEMENT AND PROHIBITIONS):**

Non-Circumvention: No authority or entity may Circumvent the will of the people **"Global Community"** to vote; elections **"must"** proceed as scheduled.



Protection of Rights: Violating God-given rights of the populace to choose their judicial officers is strictly prohibited.

Upholding Treaties: Usurping United Nations treaties or fundamental rights and freedoms to vote is illegal.

Authority: Disobeying these orders or usurping the authority of His Excellency Mr. Kidima Mubarak Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV), and "Chairman of Alkebulan" is unlawful and prohibited.

NOTICE OF SUBMISSION:

Please note that this Decree serves as a legally binding Declaration. Let all authorities, Governments, Kingdoms, and International bodies take formal notice of this Decree for Immediate Mandatory Global Judicial General Elections.
