SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE MANDATORY ARREST AND PROSECUTION FOR IMPERSONATION, HARASSMENT, ESPIONAGE AND TORTURE PURSUANT TO ARTICLE 7 OF THE ROME STATUTE OF THE INTERNATIONAL CRIMINAL COURT (ICC).

Reference is made to my previous Decree in regards to the above Subject of **"Impersonation, Harassment, Torture and Espionage"** an act which Contravenes article 7 of the Rome Statute of the International Criminal Court (ICC).and,

In direct Contravention of **Article 12** of Universal Declaration of Human Rights (**UDHR**), and **Article 17** of International Covenant on Civil and Political Rights (**ICCPR**).

By virtue of the powers entrusted to me by the Almighty God **"Allah"** and in strict accordance with sovereign authority, the principle of Universal Declaration, Rome statute of the International Court, and International Law, this Decree formally submits a Supreme Demand to the **"United Nations General Assembly"**, the **UN Security Council**, the International Court of Justice (**ICJ**), the International Criminal Court (**ICC**), to Parliamentarians as per listed above and the broader Global Community.

I, His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV)** and **"Chairman of the Alkebulan"**.

Solemnly affirm to my previous decrees that, I am not a Child of **H.E.Mr.Vladimir Putin**, neither a member of **Kaguta Family** nor related to **Dangerous untouchable Criminal Suspects David Kaiser aka Gallagher, Ben Kaiser, Bruce and others**. I declare with full authority and demand **"with Veto Power"** for immediate mandatory arrest and Prosecution of anyone who is impersonating against my will. Anyone who is associated with **untouchable Criminal Suspect David Kaiser Gallagher and his family** better consider yourself **"Null and Void"**.

Notice is hereby given that Compliance with this Decree is required with **"immediate effect"**. Please note that, **Non-compliance** will result in the automatic termination and voiding of your offices **"pursuant to article 5 and 6 of the United Nations Charter"**.

Furthermore, as stipulated under **Article 30 of the Universal Declaration of Human Rights (UDHR)**, prohibits State Officials destruction of any of the



rights and fundamental freedoms set forth in the Declaration of Human Rights.

Upholding Treaties: Violating the United Nations treaties or fundamental rights and freedoms is illegal.

Authority: Disobeying these orders or usurping the authority of His Excellency Mr. Kidima Mubarak Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV), and "Chairman of Alkebulan" "in accordance to article 8 of the UN Charter" is unlawful and prohibited.

NOTICE OF SUBMISSION:

Please note that this Decree serves as a legally binding Declaration. Let all authorities, Governments, Kingdoms, and International bodies take formal notice of this Decree for Immediate Mandatory arrest and Prosecution.
