Distinguished Excellencies, **VIP** Colleagues, and Global Community,

SUPREME FORMAL DECREE AND DEMAND FOR IMMEDIATE MANDATORY ARREST AND PROSECUTION FOR IMPERSONATION, HARASSMENT, ESPIONAGE, MURDER, TERRORISM, THEFT, SEXUAL PREDATOR, HUMAN RIGHTS ABUSES, CULT, DISOBEYING ORDERS AND TORTURE PURSUANT TO ARTICLE 6 AND 7 OF THE ROME STATUTE OF THE INTERNATIONAL CRIMINAL COURT (ICC).

Reference is made to my previous Decrees in regards to the above Subject of an act which Contravenes **article 6 and 7** of the Rome Statute of the International Criminal Court (ICC).and,

In direct Contravention of **Article 12** of Universal Declaration of Human Rights (UDHR), and **Article 17** of International Covenant on Civil and Political Rights (ICCPR).

By virtue of the powers entrusted to me by the Almighty God **"Allah"** and in strict accordance with sovereign authority, the principle of Universal Declaration, Rome statute of the International Court, and International Law, this Decree formally submits a Supreme Demand to the **"United Nations General Assembly"**, the **UN Security Council**, the International Court of Justice (ICJ), the International Criminal Court (ICC), to Parliamentarians as per listed above and the broader Global Community.

I, His Excellency Mr. Kidima Mubarak, **Founder, President, Chairman, and Global Leader of the Independent Global Movement Voice (IGMV)** and **"Chairman of the Alkebulan"**.

Solemnly affirm to my previous decrees in regards to untouchable dangerous Criminal Suspects namely David Kaiser aka Gallagher De-clerk and his family in North beach WA 6020. I hereby declare with full authority and demand **"with Veto Power"** for immediate mandatory arrest and Prosecution of **untouchable Criminal Suspect David Kaiser aka Gallagher De-clerk and his family** at address: 28 Mundford Street, North Beach WA 6020 and 32A Mundford Street, North Beach WA 6020".

CRIMINAL ACTIVITIES IN THE PUBLIC DOMAIN:

I declare him as a Terrorist Suspect, Cult, Tormentor, Impersonator, with Crimes of Espionage, Murder, Theft, Sexual Predator, Human Rights Abuses, Violating the treaties of the United Nations, Deliberately disobeying orders, Multiple breaches



Of the Court Orders, and Torture pursuant to article 6 and 7 of the Rome Statute of the International Criminal Court (ICC), and other treaties deemed necessary.

I demand that, untouchable dangerous Criminal Suspect David Kaiser aka Gallagher De-clerk **"must"** be placed on **24/7 Surveillance** and **search engine** and **"must"** be banned from accessing the Community **"effective immediately"**. He cannot continue deliberately **"stealing"** Public Money (**Funds**) and **'raping Married women'** with impunity on your watch. Human Rights Values **"must"** be respected and **"protected unconditionally"**. He is not above the Law.

I demand that, He **"must"** declare all the Money (**Funds**) received from the Global Community using my Names, Tittle and **Independent Global Movement Voice (IGMV)**. **"Must"** declare his real identity. **"Must"** declare his Wealth and the Source of Income. **"Must"** declare his sexual relationship with **"Princess Lalia Khadijah"**.

He **"Must"** declare his Conflict of Interest with the International Criminal Court (**ICC**) and "The International Court of Justice (**ICJ**)". **"Must"** declare his relationship with **"Kaguta Family in Uganda"** and **"H.E.Mr.Vladimir Putin"** of the Russia Federations. **"Must"** declare his relationship with **Hon.Micheal Rawlings** Attorney-General of Australia and the Prime Minister **Hon.Anthony Albanese**.

I also demand that, He **"must"** be Compelled to email me a formal notification of how much money (**funds**) he received from the **"Global Community"** across the Globe under my name and Tittle, **effective immediately**.

Notice is hereby given that Compliance with this Decree is required with **"immediate effect"**. Please note that, **Non-compliance** will result in the automatic termination and voiding of your offices **"pursuant to article 5 and 6 of the United Nations Charter"**, and **Article 46** of the Rome Statute of the International Criminal Court (**ICC**).

Furthermore, as stipulated under **Article 30 of the Universal Declaration of Human Rights (UDHR)**, prohibits State Officials destruction of any of the

rights and fundamental freedoms set forth in the Declaration of Human Rights.

Upholding Treaties: Violating the United Nations treaties or fundamental rights and freedoms is illegal.

Authority: Disobeying these orders or usurping the authority of His Excellency Mr. Kidima Mubarak **Founder, President, Chairman, and Global Leader of the**



Independent Global Movement Voice (IGMV), and "Chairman of Alkebulan" "in accordance with article 8 of the UN Charter" is unlawful and prohibited.

NOTICE OF SUBMISSION:

Please note that this Decree serves as a legally binding Declaration. Let all authorities, Governments, Kingdoms, and International bodies take formal notice of this Decree for Immediate Mandatory arrest and Prosecution.
