SUPREME FORMAL DECREE AND DEMAND FOR COMPLIANCE, TRANSPARENCY, FAIRNESS AND IMMEDIATE ARREST.

1. Revocation of Authority and Consent.

Reference is made to previous Communications Confirming that **David Kaiser aka Gallagher and Princess Lalla Khadija**, you are not appointed by me, authorised, or Consented to discuss, represent, or act on behalf of the “**Independent Global Movement Voice**” (IGMV) or His Excellency Mr. Kidima Mubarak. Any dynamic representing or referencing affiliation with (IGMV) is strictly unauthorised and you “must” be arrested and be Prosecuted in accordance with International Law.

2. Violations and Illegal Activities.

Regrettably, you have acted in wilful violations of all prior Decrees and repeatedly defied explicit “**Cease and Desist**” orders. Notice is hereby given to David that your actions Constitute a direct breach of prior notices and Contravene established standards under **Article 12** of the Universal Declaration of Human Rights (UDHR), **Article 17** of the International Covenant on Civil and Political Rights (ICCPR), and **Article 5, 6, and 7** of the Rome Statute of the International Criminal Court (ICC). Specific violations include, but are not limited to: Torture, Persecution, Crimes against humanity, ongoing harassment and obstruction of justice; unauthorised distribution and “**search-engine**” indexing of private media and personal imagery;

I demand that David Kaiser aka Gallagher and Princess Lalla Khadija “must” declare why they hate me so much based on their illegal actions towards me, which is a major Concern to my Health and safety.

I demand that David Kaiser aka Gallagher “must” declare why they think that, they are above the Law. Why they think that they have a right of taking away or stealing my God given rights of Independent Movement in direct violations of Fundamental Human Rights.

FORMAL DEMANDS FOR COMPLIANCE.

You are hereby formally ordered to comply with the following directives immediately:

Search Engine Tagging and Scrutiny: I demand that David Kaiser aka Gallagher and Princess Lalla Khadija “must” be tagged on the Search engine of the Panel to ensure full Compliance, transparency, fairness, and public interest review regarding all online tagging, search-engine indexing, and panel representations associated with your operations. Global Community across the Globe “must” reinforce the order by tagging them on your Platforms in the best interest of the Public.

Financial Disclosure: I demand that David Kaiser aka Gallagher and Princess Lalla Khadija “must” Provide a full accounting and declaration of all checks, funds, and cryptocurrency collected from the public using the title “**Global Leader,**” associated names of His Excellency Mr. Kidima Mubarak, Founder, President, and Chairman of the Independent



Global Movement Voice (IGMV), to the International Criminal Court (ICC) and a Copy to His Excellency Mr. Kidima Mubarak, Global Leader of (IGMV).

Conflict of Interest Disclosures:

I demand that David Kaiser aka Gallagher and Princess Lalla Khadija “must” Formally disclose all personal, Sexual and professional relationships relevant to these matters to clear any Conflicts of interest in the best interest of the Public.

I demand that David Kaiser aka Gallagher and Princess Lalla Khadija “must” Formally declare any family, personal, or professional affiliations with officials of the International Criminal Court (ICC) or judicial officers within the Western Australia Court system.

Surrender of Funds: I demand that David Kaiser aka Gallagher and Princess Lalla Khadija you “must” immediately transfer all funds, checks, and Contributions Collected from the global Community intended for His Excellency Mr. Kidima Mubarak’s happiness and a better future to the jurisdiction of the International Criminal Court (ICC), to be held pending further authorized notice from the rightful owner His Excellency Mr. Kidima Mubarak, Founder, President, Global Leader, and Chairman of the Independent Global Movement Voice (IGMV). The Court “must” immediately notify His Excellency Mr. Kidima Mubarak after receipt of the Money and Cheques. I also demand that the Global Community “must” reinforce this order.

Surrender of Media: I demand that David Kaiser aka Gallagher you “must” immediately surrender all broadcast media, video recordings,



and promotional materials featuring, tagging or referencing His Excellency Mr. Kidima Mubarak.

Disclosure of Alleged Activities: I demand that David Kaiser aka Gallagher **“must”** Provide a complete written declaration detailing any and all of Criminal activities Conducted in Iraq, Western Australia, and South Africa relevant to these proceedings due to scrutiny, Compliance, transparent/transparency and fairness in the best interest of the Public.

I demand that David Kaiser aka Gallagher **“must”** be investigated followed by immediate arrest for impersonation, CyberSecurity, Deception and Crime towards His Excellency Mr. Kidima Mubarak’s hard work as a **“Global Leader”** Founder of the Independent Global Movement Voice (IGMY).

I demand that David Kaiser aka Gallagher **“must”** declare his relationship with Michael Rawlings the current Attorney-General of Australia and Mr, Anthony Albanese the Prime-Minister of Australia.

Further demand that, David **“must”** declare why he thinks that H.E.Mr. Vladimir Putin have a right of giving orders to arrest and exile a person who is a Citizen of Australia and resides in Perth. **What role does he hold politically in the Australian Politics.**

I demand that David **“must”** immediately declare his real identity and Profession.

FAILURE TO COMPLY:

Failure to adhere to these demands of surrender or cease unauthorized activities immediately will result in formal legal proceedings by the International Courts, referral to relevant

international law enforcement agencies, and further judicial remedies under applicable law.

NOTICE OF SUBMISSION:

Please note that this Decree serves as a legally binding Declaration. Let all authorities, Governments, Kingdoms, and International bodies take formal notice of this administrative demand of arrest.
