All past, present, and pending judicial decisions, sentences, or warrants issued in absentia across all levels of government and Court jurisdictions **"must" be rescinded and are hereby declared null, void, and without legal effect.**

REINFORCEMENT OF HUMAN RIGHTS CHARTERS:

I demand that a full and total Compliance with Articles 2, 3, 4, 7, 10, 11, and 12 of the Universal Declaration of Human Rights (UDHR) is strictly mandated across all judicial and governmental Systems.

Article 10 (Right to a Fair and Public Hearing) and Article 11 (Right to be Presumed Innocent) **"must" be upheld without exception.**

JUDICIAL ACCOUNTABILITY AND REMOVAL:

I demand that any Officers of the Court, judicial officers, prosecutors, or Court official who initiates, enforces, or upholds Sentencing in absentia shall be deemed in breach of duty and charged with Serious Misconduct, Miscarriage of Justice, and Abuse of Office.

Pursuant to the principles of Article 46 of the Rome Statute of the International Criminal Court (ICC), offending officials **"Shall" face immediate removal from office and appropriate legal proceedings.**

PROTECTION OF VICTIMS AND WITNESSES:

Pursuant to Article 68 of the Rome Statute of the International Criminal Court (ICC), all victims and witnesses before judicial bodies **"must" receive full protection, respect, and safety measures to ensure fair and uncoerced justice.**

SUPREME FORMAL DECREE AND DEMAND FOR ABSOLUTE IMMEDIATE ABOLISHMENT OF COLONIAL SUPERIORITY, TRIALS AND SENTENCING IN ABSENTIA CONTRARY TO ARTICLE 7, 10 AND 11 OF THE UNIVERSAL DECLARATION OF HUMAN RIGHTS.

IMMEDIATE MANDATORY DECREE WITH VETO POWER:

PREAMBLE AND AUTHORITY:

By virtue of the power entrusted to me by the Almighty God **"Allah"** and in strict accordance with the Sovereign mandate set forth in the Independent Voice Book (Global Constitution), and Universal Declaration of Human Rights, the United Nations charter and treaties,

I, His Excellency Mr. Kidima Mubarak, Founder, President, Global Leader, Chairman of Independent Global Movement Voice (IGMV), and Chairman of **Alkebulan**, (**with immediate Veto power**), hereby formally abolish a bad Culture of trying, Convicting or Sentencing our beloved Global Community in absentia which constitutes an unconstitutional violation of fundamental human rights in accordance with General Assembly Resolution **1514(XV)** of the UN Charter and, **Article 1, 2 and 29(1)** of the Universal Declaration of Human Rights, and a direct breach of International Law.
