PUBLIC NOTICE OF PERSONAL DENUNCIATION AND IN CONTEMPT.

NOTICE IS HEREBY GIVEN that His Excellency Mr. Kidima Mubarak hereby officially and unequivocally repudiates, disavows, and denounces any personal, familial, legal, or organizational association with **"Muhammad Mukasa Kaggwa"**. He is not my brother very **"dangerous"** and will never be near my family nor my grave.

SEVERANCE OF FAMILIAL AFFILIATION:

His Excellency Mr. Kidima Mubarak formally disavows any claims of brotherly, familial, or kinship ties asserted by **"Muhammad Mukasa Kaggwa"**. No such relationship is recognized, authorized, or maintained.

DENIAL OF AUTHORITY: **"Muhammad Mukasa Kaggwa"** possesses no legal, personal, or administrative authority to represent His Excellency Mr. Kidima Mubarak, his estate, family affairs or his organizational affairs (including IGMV and associated campus initiatives) at any time, now or in the future.

FAMILY STATUS CLAIMS: **"Muhammad Mukasa Kaggwa"** is permanently excluded from any involvement in His Excellency's personal affairs, estate, memorial legacy, or designated sacred and private grounds. Any attempt to claim relationship or access under the guise of family status is strictly forbidden and rejected. **He will never be part of my family and my life.**
