"NOTICE TO AGENT IS NOTICE TO PRINCIPAL, NOTICE TO PRINCIPAL IS NOTICE TO AGENT"

1. DECLARATION OF IMMEDIATE DANGER.

This communication serves as an Emergency Formal Notice. My life is in immediate danger. As a documented victim of kidnap and torture by the Uganda Government, I am now being targeted by foreign agents and criminal suspects hell-bent on my assassination to destroy evidence against them.

2. ACKNOWLEDGMENT OF PROCEEDINGS.

I acknowledge receipt of the Corruption and Crime Commission's email dated Monday, February 2, 2026. While I confirm that further video evidence will be provided, the urgency of my security cannot wait for standard investigative timelines.

3. MANDATORY INTERIM MEASURES (500-METER EXCLUSION).

I reaffirm my demand that all offenders be prohibited/restrained from approaching me or my property within a 500-meter radius. The "illegal zooming" into my private residence and the hacking of my technological devices constitute an act of Terrorism against my life.

4. SYSTEMIC FAILURE AND EVIDENCE RECOVERY.

The unacceptable delay in state intervention has allowed repeated offenses to persist, violating the Privacy Act 1988, and Article 17 of the International Covenant on Civil and Political Rights. Above all article 12 of Universal Declaration of Human Rights (UDHR). I demand the immediate synchronization of all suspects' technological devices—including laptops, iPads, and radio calls—to recover evidence they have deleted from my personal gallery and emails.

5. FINAL DECREE.

No one is above the law. I deserve to live in peace and be protected from foreign assassins who seek to execute me in the air. I await your urgent positive response to restore my freedom and safety.
